**Proposed Ordinance Title:** Ordinance No. 2025-21 An Ordinance Amending City of Venice Ordinance No. 2024-25, Which Adopted the Official Budget of the City of Venice, Florida for the Fiscal Year Beginning October 1, 2024 and Ending September 30, 2025; by Increasing the Total Revenue by \$319,000 and Total Expenditures by \$319,000; and Providing an Effective Date
