Mr. Harmer:

- 1) **First of a series of Community Planning Workshops:**
Two Sessions – Monday, March 21 at the Venice Community Center
10:30 a.m. to Noon
6:00 p.m. to 7:30 p.m.

- 2) **Library service at the Venice Community Center** will move to a larger space that will permit the addition of:
 - Computers
 - Larger browsing collection
 - Magazines and newspapers
 - Printer/Copier

Will work diligently to complete this – adding connectivity, installing shelving, moving computers, cleaning and moving collection, etc.

Existing service will remain in place. Averaging @240 visitors daily.

✂ 3) **Arranging for a one-day/week shuttle** (2 trips) between Venice Community Center and Jacaranda Library; setting this up right now, with details to be announced.

✂ 4) **School staff declined to extend the school day for numerous reasons.**

School staff provided information regarding the afterschool care program and recommends that parents take advantage of that option:

- a) Hours of operation of the program – 3:15 – 6:00 pm
- b) Ages of students eligible to participate in the program – K-5th Grade
- c) Program fees - \$7.00 per day - limited scholarships/sliding scale available
- d) How would a parent/grandparent/caregiver get more information – stop by the school or call 941-486-2111
