Discussion took place regarding resolution support, banning fertilizer use year round, limiting fertilizer use, monitoring stormwater discharge, pest control, promoting awareness, community outreach and education, resident feedback, modifying the resolution to include water sampling program, enforcement of existing ordinance, nutrient management plan for golf courses, schools, and government properties, Florida Friendly Landscape, vegetative buffers along the waterways, marking storm drains, and slow release fertilizers, ponds, homeowner associations (HOAs) educating residents, obtaining data, monitoring stormwater outfalls, reclaimed water, obtaining expert input, infrastructure keeping up with growth, Sarasota County's water quality staff, Southwest Florida Water Management District (SWFWMD), removal of septic tank systems, and state legislation.

Rob Merlino, 252 Glen Oak Road, Venice, commented on the city's stormwater system and treatment, and red tide's economic impact to the city.

Todd Josko, representing TruGreen, spoke to best lawn care practices, proper fertilization education, not supporting year round ban, and

encouraging less fertilizer use.

Christopher Ferrante, P.O. Box 294, Venice, noted he is not in support of the resolution, and spoke regarding scientific studies on fertilizer ban, red tide, and proposal being too narrow.

Mac Carraway, Environmental Research and Education Foundation (EREF), opposes year round ban, and spoke to education and collaboration.

Sharon Roush, President, Venice Regional Bayfront Hospital, spoke to expanding hospital services and needs, neighborhood workshop, neighborhood advisory council, and project goals, completion date, and team.

Dan Bailey, representing Sarasota County Public Hospital Board, spoke to parcel, pre-annexation agreement provisions, property zoning, hospital windows, special exception, building height restriction and design, hiring outside resources for site and development plan approval, staff review process timeframe, building plan review and approval, SWFWMD, trees, building, and site preparation permits, building foundation work, and working with city staff for hold harmless at risk of the developer.

Discussion followed on fast tracking permit, footings, design process, and site and development plan approvals.

Mr. Shrum commented on fast tracking process, outside inspector involvement, quality control, staff involvement in the review process, and code.

Discussion continued regarding certificate of need, pre-annexation agreement to include mixed use corridor, building height and architectural design, land development regulations (LDRs), property zoning, Venetian Gateway standards, and potential hurricane shelter.

Action to Deter the Impact of Red Tide in the Gulf (Daniels)

Mr. Daniels discussed his position paper regarding action to deter the impact of red tide into the gulf.

Discussion took place on motion to monitor the ten city outfalls discharging into the gulf.

Mr. Clinch responded to council questions regarding expectation of nutrient levels, outfall treatment systems, major outfalls, and volume of water flowing through the outfalls.

Discussion ensued on monitoring all major outfalls in the city flowing into the gulf, amending the motion, and funding.

A motion was made by Vice Mayor Daniels, seconded by Council Member Cautionero, that all surface outfalls flowing into the gulf in the City of Venice must be monitored to assure that the outfalls are not adding contaminants that pollute the Gulf of Mexico and provide food sources for red tide.

Discussion ensued on staff guidance and providing a remedy, broadening scope of expertise, community outreach, stormwater treatment systems, reducing nutrients, retention ponds, enforcement of current fertilizer ordinance, creating a nutrient management plan, golf course management plan, vegetative buffers along the waterways, marking the storm drains, and comprehensive resolution.

Mr. Lavalley spoke regarding outfall monitoring.

Discussion ensued on including oyster and sea grass monitoring, county monitoring data, October 24, 2018 Environmental Advisory Board (EAB) meeting, community outreach, obtaining expert input, University of Florida research, planned unit developments (PUDs), septic tanks, Seaboard Area treatment system, outfall monitoring timeframe, and August 20, 2018 approved council motion to direct staff to develop an outfall monitoring system plan by March 2019.

Vice Mayor Daniels withdrew his motion and Mr. Cautionero withdrew his second.

Mac Carraway, Environmental Research and Education Foundation, requested to be included in red tide discussions.

Discussion followed on inviting a representative from the state university system to the October 24, 2018 EAB meeting.

Recess was taken from 3:17 p.m. until 3:26 p.m.
