<u>24-0414</u> Hurricane After Action Review Next Steps

Discussion took place regarding next steps, some topics being global issues, including more specifics in final report, Flamingo Ditch, similarity of reports from initial City presentation and the survey, volunteer groups within communities and neighborhoods, things that residents can do themselves, sandbag distribution, exploring alternative sources for assistance, completing the summary of open ended questions, whether each population type's comments were received, working within Sunshine Law, and scope of recommendations.

Assistant City Manager Clinch spoke about the process, distinguishing between perceived concerns and actual need for improvement, presenting staff after action report, and involving directors as needed for specific topics.

Discussion continued regarding City Hurricane After Action Review presentation, discussion at next meeting, next steps, forming recommendations without influence from the City's report, benefit of having both of the reports, timing, and sequence of tasks.

City Manager Lavallee commented on the staff report being objective with consideration of Law and procedure, Board focusing on Council directive, not making recommendations based on those comments that are misperceptions, and examples of misperception of City authority.

Discussion took place at reviewing provided survey information, when the Board should review City's report, and tasks for upcoming meetings.
