INDIVIDUALS MONITORING JONES IGNORED "RED FLAGS"

Lyndon Jones, who has pleaded guilty to stealing more than \$76,000 in federal money, which were supposed to go to internships for teenagers, had a documented record of serious abusive behavior and flawed accounting practices. "Red Flags" concerning Jones

deficiencies were ignored by Sarasota public officials and others involved with monitoring Jones, as the administrator of the Man Up youth program.

These public officials and other involved with Jones should be concerned of their inactions, due to a recent comment made by Johnny Hunter Sr. in responding to Jones's guilty plea. According to Hunter, who is the Publisher of TEMPO NEWS and has Jones as a member of his Editorial Board, Jones stated to him before his arrest: "If ever arrested he (Jones) would tell authorities all he knew of any illegal activities he was aware of." Jones, who is facing ten years in a federal prison, according to his plea agreement has agreed to cooperate with federal authorities.



KIRSCHNER

One of the Sarasota City officials is former Sarasota City Commissioner Kelly Kirschner, who despite on numerous occasions of being informed that Jones had exhibited documented serious abusive behavior issues, ignored those warnings and voted to approve moving forward with Jones as Executive Director of Man Up on two separate occasions.

Kirschner approved Jones moving forward with Jones, as director of the Man Up youth program at a Sarasota City Commission meeting on 4/11/11 with these words:

"When I first came in office, it was Lyndon Jones just talking to me in the Robert Taylor Center alone and saying he had an idea for a summer youth program. Now he has a lot of great people around him and a Board and he's reaching out to the Hospital, to the Airport, private firms, like the firm where Mr. DuBose and Mr. Bailey work at, and I hope he continues to grow, because we need about five, ten, fifty Man Up organizations throughout the City."

Despite numerous calls to Kirschner to comment on the plea agreement Jones has made with federal authorities to plead guilty with embezzling over \$76,000, which were intended to go to youths in Jones's administered Man Up program, Kirschner has failed to return calls.

Attempts to contact the other four Sarasota City Commissioners, who voted to approve Jones Man Up program in 2011, there has been no response to ascertain if they were aware of Jones behavioral and administration deficiencies before his arrest, except for former Sarasota County Commissioner Terry Turner.



When Turner, who is a former professor from the University of North Dakota and million dollar hedge fund operator, hung up on this reporter when asked to explain why he voted to support Jones to administer the Man Up youth program, despite documentation that Jones exhibited abusive behavior and lack administrative skills.



A recent comment by City of Sarasota Assistant City Manager, Marlon Brown indicates that all five Sarasota City Commissioners were aware of Jones' deficiencies. For example, Brown stated he would be "shocked" if the City Commissioners who approve Jones as Administrator of the Man Up program were unaware of Jones's shortcomings.

Jones indicated that Commissioner's Terry Turner, Suzanne Atwell, Richard Clapp, Kirschner and Commissioner Fredd Atkins, who Jones refers to as his "mentor," were willing "to do business" with these words at City Commission meeting in 2013:

"It has been a blessing to do business with you, Mr. Clapp, my rep, Mr. Atkins, my mentor and lead, and thank you, Mr. Kirschner for all for your contributions to us."

Jones continued at that meeting with these words of support from City Commissioners with these words: "An attempt to find more dollars as they were stated when Commissioner Clapp was Mayor at the time, and has always been the echo of Commissioner Atkins out of his District, as well as the cry of Commissioner Turner and the encouragement of Commissioner Atwell and the constant support of Commissioner Kirschner."

Commissioner's Turner and Atwell recent attempts to distance themselves from Jones appears to be disingenuous. For example, both Turner and Atwell have stated after Jones's arrest that they did not vote to support Jones directed Man Up program on 4/18/13. They failed to mention that they did vote to fund Man Up on 4/8/13. Their vote on 4/18/13 was to approve an additional \$32,000 for youth programs to the YMCA, while praising Jones's administered Man Up Program.



BAILEY

Local attorney Dan Bailey, who Kirschner refers to as one of the "Great People around him (Jones)," actively supported Jones as Executive Director of Man Up publicly and in meetings with Sarasota public officials. Bailey recently admitted being told of Jones's documented abusive behavior, but continued to support Jones.

Despite admittedly being informed of behavioral issues with Jones, Bailey came before the Sarasota City Commission and asked approval for funding Man Up with Jones at his side with these words: "Mr. Mayor, I am here to speak on behalf of Man Up so I encourage you to look favorably upon Man Up."

Two weeks later Bailey came before the Sarasota City Commission with Jones at his side requesting another \$32,000 in public funds for Man Up with these words:

"I'm Dan Bailey. I'm a supporter of the Man Up organization. I try to help find partnerships with other institutions that can help provide jobs, but I will tell you that the Man Up Organization has a functioning Board now, and they had a Board in the past."

Bailey continued, "It was a good Board, but we think it is even better and has more people on it now and will be attentive particularly in light of what we learned other sister organizations are undergoing, making sure that we have good governance and good attention by disinterested directors looking on the organization."

Bailey backed up those words of support for Jones as Executive Director of Man Up by recommending that the Sarasota/Manatee Airport Authority and Sarasota Memorial Hospital, which he is the paid legal council, cooperate with Jones and his Man Up Program. In the charges against Jones by the federal authorities, Jones was double billing both the Airport Authority and Sarasota Memorial Hospital.

Despite numerous "red flags" concerning Jones' behavior issues, Jones continued to be appropriated hundreds of thousands of dollars in public money to supervise Sarasota's youth. Despite Jones's documented behavioral and administrative deficiencies, which caused some Sarasota City officials to raise concerns with their supervisor, Jones continued to get public funding

And this group of locals (that term is used with disdain and dishonors all real surfers, and will hence forth be used as a derogatory term), persist in hassling and attempting to intimidate other surfers who come to Venice pier to surf. Mind you these are 30,40,50 year olds Though they may have been raised in Venice They never surfed the pier until the last 10 years prior to that it was Bicknell st, POV, or Ocean Park. Now they try to claim the Venice pier with an angry localism mentality as if they have been surfing there for a hundred years or like the Hawaiians who had their land and heritage taken away from them. With their strength in number and gang mentality they verbally abuse and threaten other surfer in the lineup, vandalize cars and steal property form the beach. And local law enforcement, beaches and harbors and life guards inability or lack of concern to do anything about this group and the laid back non-confrontational attitudes of real surfers only emboldens this group of what can only be describes as small minded losers. Who haven't realized that dog town is dead, the 70's are over and the beach doesn't belong to them. No longer taking their abuse verbal abuse I gave it right back to them, which blew their minds. How dare one person stand up to all of us and expose us for the wussies we are, whhaaaaaa!!!!!!!!!!!!

..... I refuse to cower down and be run off, you I'm an alpha so you only have 4 options as for as I'm concerned , #1 continue your lame loser cowardly acts and perpetuate your own self misery #2 accept that times have changed and learn how to share, #3 leave, #4 kill me. Because the only way you are getting me to leave Venice is in a body bag and I'll make sure mine is not the only one.

At one time I was hoping to eventually make friends with your group but now that I know how you are I would never want to be associated with such group of douches.

If you taught your children how to respect other people, share, and fair play maybe one day if they become good enough surfers they would have a chance on the pro tour. But if they show up with the attitudes you are teaching them they will be weeded out like every other "A" hole has been no matter how good they were. And at the very least you would be raising thoughtful fair citizen's not self-centered brat with a chip on their shoulders who will go nowhere in life, just like you.

What you don't realize is the more you hassle me the happier I become, because I know I'm winning. I can only imagine how frustrating it must be for you to have been emasculated by me and to realize you have no power at all. Let's see I run a successful business at 3 locations in Marina Del Rey, Santa Monica and Venice beach hire 5+ local instructors each year and pay salaries and taxes for them, I spend 10s of thousands on marketing with local business, I purchasing equipment and supplies at local business,

So all told I probably generate a half a million or more for the local economy each year. Google a multibillion dollar international company picked my company to showcase. They even shot a commercial of my company in Venice beach bringing in countless dollars for the city with fees and permits. This international commercial will make my company grown and stimulate even more local business and tax dollars, I bring happiness and joy to peoples lives, I perpetuate the California iconic lifestyle with my 2 classic VW buses that i use for my business (the ones you vandalize). This is what I've accomplished here in less than 3 years and you have been here 40 + years and what have you done other than claim something that doesn't belong to you and maybe pay for your parking meter. You are everything that's wrong with surfing magnified and personified.

Why don't you take this time for an intellectual rebuttal I know you can write since you did so well

So to all visiting surfers, tourist, and local residents who are tired of these punks, if you see any of the fore mentioned, start filing reports with the police, call your city council, beaches and harbors representatives, captain of the lifeguards, take photos and videos of any vandalism, theft, or harassment.....

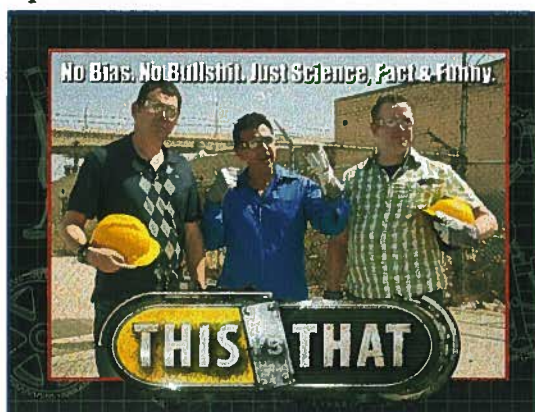
