ORDINANCE NO. 2024-14

AN ORDINANCE AMENDING CITY OF VENICE ORDINANCE NO. 2023-34, AS PREVIOUSLY AMENDED, WHICH ADOPTED THE OFFICIAL BUDGET OF THE CITY OF VENICE, FLORIDA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024; BY INCREASING THE TOTAL REVENUE BY \$1,600,000 AND TOTAL EXPENDITURES BY \$1,600,000; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Venice, pursuant to Section 200.065, Florida Statutes, adopted its Operating Budget, Revenues and Expenditures, and Capital Improvement Program for Fiscal Year 2024 by approving Ordinance No. 2023-34 on September 25, 2023, said budget being \$175,493,956; and

WHEREAS, the City of Venice increased said Operating Budget by the amounts of certain commitments for purchases (i.e., encumbrances) and projects, totaling \$46,910,132 and \$43,405,075 respectively, up to an "Adjusted Original Budget" amount of \$265,809,163 for Fiscal Year 2024; and

WHEREAS, the City of Venice amended its Fiscal Year 2024 budget by approving Ordinance No. 2035-55 on December 12, 2023 for a decrease of \$16,345,020, said budget as amended being \$249,464,143; and

WHEREAS, the City of Venice amended its Fiscal Year 2024 budget by approving Ordinance No. 2024-01 on January 23, 2024 for an increase of \$248,394, said budget as amended being \$249,712,537; and

WHEREAS, the City of Venice amended its Fiscal Year 2024 budget by approving Ordinance No. 2024-05 on April 9, 2024 for an increase of \$664,911, said budget as amended being \$250,377,448; and

WHEREAS, the City of Venice desires to further amend its Fiscal Year 2024 budget by increasing the total revenue and total expenditures by \$1,600,000 as detailed in Exhibit "A", attached hereto, said budget as amended being \$251,977,448; and

WHEREAS, of the revenue needed to cover increased expenditures, \$1,600,000 comes from Building Fund reserves; and

WHEREAS, this amendment is authorized by Section 166.241(8), Florida Statutes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA:

SECTION 1. Ordinance No. 2023-34, which adopted the City of Venice Operating Budget, Revenues and Expenditures, and Capital Improvement Program for Fiscal Year 2024, as previously amended, is hereby further amended as detailed in Attachment "A," which is attached hereto and incorporated herein by reference.

SECTION 2. This Ordinance shall become effective immediately upon its approval and adoption, as provided by law.
