STRATEGIC PLAN GOAL: Upgrade and Maintain City Infrastructure and Facilities

SUBJECT: Approval of the ranking of proposers for RFQ 3089-18 for Professional Architectural and Engineering Services for the City of Venice Fire Station #1 and authorize staff to begin negotiations with the top ranked firm.

Background:

Request for Qualifications (RFQ) 3089-18 Professional Architectural and Engineering Services for the City of Venice Fire Station 1 was distributed on September 1, 2018. Four (4) proposals were received on October 5, 2018. On October 22, 2018, an evaluation committee met to review, discuss, and score the proposals received. The four (4) proposals were ranked in the following order and the top three (3) firms were invited in for interviews/presentations on November 8, 2018.

The third ranked firm, Dewberry Architects, Inc., withdrew from consideration on November 2, 2018.

On November 8, 2018, the evaluation committee met again to hear oral presentations and conduct interviews with the remaining two (2) shortlisted proposers. The proposer's were ranked in the following order:

Based upon the final scores and ranking, the evaluation committee recommends authorization for staff to negotiate an agreement with the top ranked proposer, Sweet Sparkman Architects. In the event that the City is unable to come to terms with the top ranked proposer, staff will end negotiations with that firm and begin negotiations with the next ranked firm until a suitable agreement can be reached.
