Dear Ladies and Gentlemen:

My name is Tova Weinstock, and I recently became a resident of the Venetian Golf and River Club, residing at 101 Terra Bella Court. For over five years, during the twelve years I was a resident at the Wynmoor Country Club in Coconut Creek, Florida, I was an avid pickleball player. We had eight courts located near our condos, swimming pool and tennis courts.

Based upon my experience, as much as I enjoy playing pickleball, I am against the proposal to install three courts near the River Club, tennis courts and pool area at the Venetian for the following reasons.

- 1. The noise created by even one pickleball court is substantial, whether there are four players on one court, eight on two or twelve on three. This is true even if there is a special fence or other barrier installed to reduce the noise. The noise created remains intolerable to those nearby.
- 2. Placing the courts near residences, outdoor dining areas, tennis courts and swimming pools, as is proposed at the Venetian, will create a constant noise problem for all those living in the nearby condos or trying to relax while enjoying the recreational or dining activities. We found at Wynmoor that there was no way to effectively reduce the noise, and consequently, the quality of life was permanently reduced. There is no reason to subject a large number of residents to a similar fate simply to satisfy the desires of a small number of pickleball players.

Given the size of the Venetian community and potential impact of this decision upon all the residents, the matter should be reevaluated and a better solution found.
