Thank you for your comments concerning the Jetty. The objective of the proposal under review is to maintain the current food and toilet services at the Jetty. The provocation for the initiative is to allow removal of Anita's Sandcastle without loss of those public services. The current structure is located in the Army Corps of Engineers (ACOE) right-if-way (ROW). The area affiliate to the ACOE, West Coast Inland Navigation District (WCIND) has requested the removal of the building as it obstructs access to supporting infrastructure that reinforces the banks of the intra-coastal waterway. Anita's lease expired in 2015. Because the ROW encompasses most of the Jetty it would be very difficult under the strict regulatory rules today to obtain approval for creation of a new permanent structure. We have calculated that the public toilet facilities experience 1,000 flushes per day, indicating the substantial use by visitors. The food service is also popular. With regard to the current proposal, there are still many details unresolved.

Mr. Lavallee:

Thank you for responding to me so expediently, and, on a Sunday as well! While I have heard much of the history, it is especially helpful to have an accurate and concise summary of it.

I believe that the problem with Humphris Park has most to do with its size, its proximity to residential property, and, that it is essentially a dead end/turn around for Tarpon Center Drive. At most other

parks, locating rest rooms and/or a food concession may be more easily distanced from residential property. Further, I am surprised that after twenty plus years, the Army Corps of Engineers (ACOE) would really be that anxious about clearing the Right-of-Way (ROW). I feel the ACOE and their area affiliate, West Coast Inland Navigation District (WCIND), should be approached about allowing continued current use of the ROW with the understanding that we would vacate the area if it was ever needed for an ACOE use. If such an understanding were accomplished, than a food concession lease could be renegotiated with Anita (or another vendor if a favorable lease could not be agreed upon with Anita).

If the current configuration cannot be kept, I would strongly encourage the City to drop the concept of having bathrooms and portable food vendors located on such a small, dead end property. As I stated before, Humphris Park was primarily visited by fishermen, residents and visitors enjoying a hot dog at Anita's, or residents and visitors watching our beautiful sundowns. We really do not need to encourage additional traffic to this small park. Frankly, I was surprised to learn that another vendor has been allowed to sell ice cream at the South Jetty. And, please look at the North Jetty with all the parking it has. Can you imagine the mess we would have if that much traffic were encouraged to come to the South Jetty? What quality of life would we have as a residents at the Jetty Villas?

I am gratified to know that you are in agreement that the nighttime activity needs to be addressed, however, it is so much more than just noise. As I stated in my first communication, Humphris Park has become a destination for young people who have nothing to do but loiter and drink alcohol. One wonders if these individuals are from Venice, or, if we are attracting these juveniles from other communities. These individuals trash our little park and leave their mess for our taxpayers to pay for the cleanup. And, they do not confine their messes to the park property, but rather, these delinquents spew their trash, beer bottles and beer cans on our property for us to clean up as well. As I stated, the nighttime activities include racing extremely noisy vehicles with loud squealing tires, yelling and screaming obscenities, drinking alcohol excessively, trespassing on our property including camping on our green space as well as climbing on our roofs.

Further, I can tell you that when the Park fills up with vehicles, some individuals end up parking in our private parking spots located along Tarpon Center Drive near the Jetty. That happened to me just two weeks ago. That is a problem when you have groceries to carry in, or, in some cases where a resident cannot physically walk any significant distance. When someone violates one of our spaces, our only option is to park in the back lot across from Inner Circle Drive which, as you know, is quite a distance from our units close to the Jetty.

Again, we believe that strong consideration should be given to just leaving the current configuration alone. That would obviously be the least expensive option. Along with a very strong policing presence, we believe that the individuals that congregate in the evenings at the Park may choose to locate in a different place away from residential property.

Thank you for your communication concerning the Jetty. A little background information may be useful in discussing the current situation. My understanding is that more than 20 years ago, Anita's Sandcastle was placed on the Jetty in response to a public demand for food service and bathrooms. However, contrary to public policy the structure was placed in an Army Corps of Engineers (ACOE). Right-of-Way (ROW). The ACOE and their area affiliate West Coast Inland Navigation District (WCIND) have been anxious for us to remove the structure from the ROW. The lease for operation of Anita's expired in 2015. This provoked a discussion with WCIND about removal of the structure. The City agreed to remove it to achieve compliance with the ROW policy. In the meantime, mobile food vendors have been requesting permits to operate in Venice. There is currently one vendor selling ice cream on the Jetty during hours when Anita's is not open.

To meet the public expectation of food service and bathrooms on the Jetty, the City is considering a mobile vendor ordinance that would allow vendors on a limited and specifically located basis to operate on the Jetty once Anita's structure is removed. The site considered is at the north end of the Jetty, away from the residential properties. The reason for considering the mobile service is that it is portable and easily removed in case of a hurricane or other dangerous weather.

The proposed ordinance is under review to modify operating conditions, including hours of operation. At the same time, we are examining the current disposition regarding vendor service on the Jetty. It was public requests that initially led to the creation of Anita's Sandcastle. Public opinion may have changed,

Concerning the nighttime noise, I consider this to be a nuisance we need to address. Police have conducted periodic checks of the Jetty, but based on recent history it may be necessary to take a more aggressive approach. I would be willing to discuss this with you and/or your neighbors. Please feel free to contact me. Thank you

When we first purchased property at the Jetty Villas in 2003, Humphris Park was primarily visited by fishermen, residents and visitors enjoying a hot dog at Anita's Sand Castle, or residents and visitors watching our beautiful sundowns. Today, the uses have expanded to include nighttime activities such as racing extremely noisy vehicles with loud squealing tires, yelling and screaming obscenities, drinking alcohol excessively, trespassing on our property including camping on our green space as well as climbing on our roofs. Our sense is that Humphris Park has become a destination for young people who have nothing to do but loiter and drink alcohol. One wonders if these individuals are from Venice, or, if we are attracting these juveniles from other communities. These individuals trash our little park and leave their mess for our taxpayers to pay for the cleanup. And, they do not confine their messes to the park property, but rather, these delinquents spew their trash, beer bottles and beer cans on our property for us to clean up as well.

With such activity occurring, why would anyone think it to be a good idea to expand services in such a small dead-end area. I cannot imagine placing unsightly porta potties on that small property, or, encouraging various vending trucks to pull up on that small plot of land to sell different food and drink. Anita's Sand Castle has only been open for coffee in the morning and very limited food until 2:00 or 3:00 PM in the afternoon. Frankly, the non-stop traffic on Tarpon Center Drive causes such congestion that backing out of our parking areas has become problematic. Even crossing the street to visit the Crow's Nest is a challenge.

The issues described above are not just a nuisance problem, but, are really a public safety issue. As hard as our law enforcement may try, the level of policing needed to maintain a safe and peaceful environment is simply too great. Hugh,

I really do not have anyone to request information from on the week end and please remember, I can request but have no authority to delegate anything to staff. About the best I can do is ask the proposer - the City Manager - to provide his supporting documentation or fulfill your request. The questions you have asked go far beyond the scope of the Ordinance and he may not have the time required to provide a white paper as many of the topics were not up for discussion by anything on the agenda, but I will leave that to him. It is unfortunate that our recording of the meeting is of such poor quality that it is very difficult to review. I am told that the defective units have been repaired or replaced. If memory

serves me correctly, the discussion was about an Ordinance regarding mobile vending Ord. No. 2016-05.

There was nothing in the agenda packet about port-a-potties that I recall, however, I do recall discussion on the topic. The discussion was on a letter submitted by a resident, not an agenda item submitted. It is unfortunate when we get last minute submissions and they become an issue when we have not been able to ask staff to provide any back up data, in fact, some of the persons seated on the dais did not even have a chance to read through the letter. Unrelated to the Ordinance is your comments on parking. No one has any reserved parking on the Jetty, with the exception of perhaps a law enforcement spot. Anyone can use available public parking for any reason, whether it is to dine at a local establishment, fish, sight see, or visit a person at one of the nearby residences. I do not recall any signs that limit parking hours. The Sandcastle building was never approved by the Army Corps of Engineers or by WCIND and has always been a point of contention. The proximity to the water on the entire South Jetty makes it impossible to legally move the building. The current building standards would require a building that is far more storm resistant than the current building and the same goes with the restrooms (look at the restrooms at Caspersen Beach). A long time ago I gave the City Manager some examples of portable rest room to consider when and if the Sandcastle is removed. It should not have been part of this discussion, but it did come up. The rest room example I gave the City Manager was a trailer, not a port-a-pottie; the thought was that the trailer (air conditioned, ADA compliant, and flush toilets with running water and hooked up to the sewer system) could be moved away from the jetty in the event of an imminent storm without the multi-million dollar building like that at Caspersen.

I had a few minutes to go this far with an explanation, but I have a very committed weekend and will wait till we can talk later for anything else. Yesterday's answer to you was given while I was working at the BBQ bash from 5:00 a.m. until 2 p.m. and then another event from 4 p.m. until midnight. I will have to try to stop council from discussing topics not on the agenda -The Sandcastle and port-a-potties - are two examples, although I really do not want to infringe on questions raised by Council Members as a Council Meeting is the only time we have to openly discuss what is on our mind. Many times these are items that are then discussed with far more detail at a later meeting. I will ask the Clerk to not let residents distribute information to Council on the day of a meeting, but rather to give the information to her so that she can decide if it is something that needs to be seen immediately or can be given to us for later review. In the case of this letter, many of the topics went far beyond the mobile vending and the letter should have been placed on a future agenda so that we could have given proper attention to the items that ended up being discussed.

I'm a resident of Jetty Villas, the villa community that abuts Humpris Park. My parents moved to Jetty Villas in 1982., and I retired here in 2008. Although they are no longer alive, they spent over 20 years in retirement enjoying all of those years in Venice. My Dad was especially happy when he was fishing off the South Jetty - my Mom was quite fond of the hotdogs! During all those years, our family often remarked on the wonderful parks throughout Venice - and we were especially fond of the one next to us, especially at sunrise and sunset.

As the years have gone by, we've all noted the increase in traffic on Tarpon Center Drive, driven almost exclusively by the attraction to the park. More disturbing to me is the demeanor of the kids that frequent the park, from the coarse language to the drugs and alcohol consumption.

Over the last week, I've read several emails and articles concerning proposed plans for the future of Humphris Park. I must say that I find the proposal to be very disturbing - even scarey. I can only assume that the people making such a proposal have never spent any time in the park during season - rarely is there parking available during the day, especially if the surf's up and the winds right. At night, the kids come out to play - even though the park is suppose to be closed. There is little police presence after sunset tho they do respond to calls of a specific nature. We try to be "good neighbors" - we all remember what it was like to try to find fun on long summer nights.- so limit calls to major offenses. If this proposal becomes effective, I'd wager the number of offenses will increase dramatically.

I'd ask that you take the next year to study the traffic and impact on the park - and not just in the summer when things normally quiet down, but through next season too. Visit the park throughout the week and at night. Try to negotiate with the engineer corps - it's been done successfully in the past - or find a less invasive alternative.

I am writing to you on behalf of my husband and myself. We became residents of the State of Florida in 1992, just after purchasing our Jetty Villa. We were thrilled to own such a beautiful condo in a most unique area. Our grandchildren loved coming to stay over their school breaks enjoying the pool and feeling safe walking the beach.

I recall with a grateful heart the first beach renourishment many years ago. The Army Corps of Engineers made it an historical event! We were accepting of the 24 hour equipment noise, port-a-potties, workers trespassing....but no complaints from us! The beauty of all that sand coming in was a sight to behold!

In 1992 the hot dog stand was on a trailer and driven into the park each day. This was greatly improved by providing a permanent and eye appealing building that would replace the trailer. The City determined it was important to add restrooms and bait sales. Again, noise, inconvenience and trespassing was tolerated by the JV owners without complaint.

Twice since we have lived here, the Crow's Nest Restaurant requested an expansion which obviously would increase traffic and noise. We were good neighbors to the local business owner and without complaint did not interfere with their improvements.

As more and more people discovered this beautiful City on the beach, traffic and noise increased. People who do not live on the water enjoy coming to watch the Page Two

boats, have a hot dog and view the gorgeous sunsets. There has been a dramatic increase in traffic with the tourist boom in Southwest Florida. This is wonderful for all the local businesses and for our State as a whole. However, there are some downsides. One of them being the homeless who come to a warm state adding to the existing people who are not mindful of private property...who utilize our common areas for entertainment, sleeping, cooking, defecating and being generally quite unruly.

Some time ago, the City posted signs that prohibit alcohol on the beach, no pets, no smoking and no overnight parking. Unfortunately, the rules are not enforced. We occasionally see a Police cruiser in the park with an officer taking a phone call. But we do not see them confront the problems. Never. So we take it upon ourselves to attempt to deal with and monitor very difficult situations.

In trying to protect our property from trespassers, we (the owners) are put at risk. Many of us are over 70 years of age and some are quite physically handicapped. I can't imagine the City not having concerns about all of us trying to do the work of the Police Department! Are we cautious? Yes! But each time we go out after dark to deal with someone urinating on our courtyard, or sleeping in a lounge chair, or up on our flat roofs, it is quite possible we could be in harm's way.

It is a regular ordeal for JV owners to clean up the common areas of broken glass from beer wine & other alcoholic beverages. We dispose of condoms, underwear left behind and lots of garbage.

Now we are told that the lovely building housing the hot dog stand will be removed and replaced with multiple food vendors with trucks and trailers taking over Humphris Park. Porta-a-potties will be brought in to replace the permanent bathrooms that were demolished. And did I hear correctly? The City is also going to permit the sale of alcohol?? I have a few questions about this proposal:

- -Will background checks be conducted on each of the vendors?
- -Will the vendors need to pass a drug test?
- -Will there be a limit on the number of vendors?
- -Will vendors be assigned to a certain parking spot to permit the tourists continued access to watch a sunset or take a walk out on the Jetty?
- -As vendors and tourists jockey for parking places, how will this be

monitored?

- -Who is liable if there are altercations between vendors and the public?
- -Will the Health Department ensure the food storage and preparation is sanitary?

All of these changes will increase traffic on Tarpon Center Drive. Have you considered the portable signs that tell drivers how fast they're traveling? The limit is 15 mph and definitely not adhered to. How about speed bumps?? Now I ask each one of you....would you want trucks, trailers, noise pollution, garbage, intoxicated and obnoxious individuals outside your residential front door? I think not! I can't imagine how you can justify your recommendation to the community of residents at Jetty Villas.

Our comments are not a critique of the Venice Police Department! We are fully aware of the budget constraints and appreciate the general overall protection provided by Law Enforcement. Perhaps we have been remiss in not calling 911 every time we had to deal with an unpleasant issue. Speaking for myself I believed Law Enforcement may have had more important things to deal with than to be called here every time there was a trespasser, someone vandalizing, foul language all hours of the night, speeding cars, motorcycles and scooters, vehicle radios blasting and strangers in our pool and on our roofs. It is a constant sleep disturbance. But we continue to do our best to take care of these nuisances ourselves.

As a community of home owners, I ask you to please work with us. Your decision, as it stands, diminishes the values of our homes. It puts our residents at risk. Those who have a unit for sale are straddled with the black cloud of what may happen in Humphris Park. There has to be a better answer than the idea currently on the table.

May I suggest that if we cannot come together on a reasonable solution, how about requesting the services of Nancy Detert and Vern Buchanon to mediate on our behalf? To get to first base we may just need an unbiased third party.

Speaking for my husband and myself, I ask you to do the right thing. We believed each of you would do what is best for Venice when we voted for you. Please don't destroy our little community of Jetty Villas.

We look forward to the possibility of finding harmony.

Re Humphris Park

My family and I are the owners of Jetty Villa number 1 (the "Villa") in Venice, which is the northernmost villa in the Jetty Villa Association. As such it is the closest villa to Humphris Park and will be most directly impacted by any change in use of Humphris Park.

The Villa had been purchased by my wife's parents, Lillian and James Kennedy, over 30 years ago and has played a special part in the family over these many years. Although the Kennedys are deceased, their great grandchildren are now eager visitors to the Villa (and visitors to Humphris Park looking for dolphins) creating their own special memories. As such, it is with great concern that I read that the City of Venice is considering "improvements" which may change the character of a very special corner of Venice. My concerns include both the direct negative impact on the ambience on the Park itself as well as the indirect negative impact on our enjoyment of our own property.

I understand the proposals that the City is considering include putting elevated portable restrooms and a number of food trucks in the park. Although I have not seen any specific plans or renderings, the fact that such things are being seriously discussed by our elected officials is extremely disturbing. I believe that the objections to the proposal are both aesthetic as well as legal. The aesthetic speaks for itself. I doubt that anybody responsible for the planning would think it is a good idea to have portable restrooms and food trucks in their own backyard – which is exactly what you would be doing to a fair number of tax payers. I have seen a number of eloquent letters sent to you by other homeowners at the Jetty Villas and I support them and will not repeat the points that were so well stated by them.

From a legal perspective, the proposal is inconsistent with the general purpose of zoning laws – which is to separate uses that are thought to be incompatible. Taxpayers are entitled to a fair expectation of reliance upon the zoning laws to prevent new development from interfering with the existing uses and/or to preserve the character of a community. Our own Code of Ordinances states that the Land Development Code (the "Code") is an act to protect and preserve the public health, safety, and general welfare and to assist in the orderly and controlled growth and development in the City.

As you know, Humphris Park is zoned open use conservation ("OUC") property. Section 86-70 of the Code states that the intention is to retain, insofar as desirable and practicable, the open character of OUC land. Why is it not desirable and practical to retain the open character of our lovely Park?

The Code goes on to state that "permitted and permissible uses are basically limited to conservation, recreation and, with certain limitations, other uses not contrary to the character of the district". The Code further states a number of specific permitted principal uses, the only one of which is relevant to the proposal is "publicly owned parks, recreation areas, and uses and structures appropriate to such activities". The provision goes on to state that permitted accessory uses and structures in the OUC district are "uses and structures which are customarily accessory and clearly incidental to permitted or permissible uses and structures". Finally, the Code goes on to state that prohibited uses and structures include "[C]ommercial uses, except as specifically permitted or permissible special exceptions".

The City of Venice has over 30 parks. Very few of the active parks offer concession stands (all of them that do are housed in permanent buildings). Only half have restroom facilities (all of them that do are housed in attractive permanent buildings). There is not a single park in Venice that offers portable restrooms Clearly the placement of portable restrooms and food trucks are clearly not customarily accessory and clearly incidental to permitted or permissible uses and structure. It is telling that new fast-food restaurants (not to mention diesel-fume spewing food trucks) are not even allowed in Commercial, Neighborhood Districts and Commercial General Districts). How is it that food trucks could be permitted in an OUC abutting residential property?

Dear Mayor, Council Members, City Manager Lavalee and Deputy City Manager Bramble:

I am writing to express my concern with the process being followed with regard to Humphris Park. As I understand the issue the City Council is considering the removal of the Sand Castle and the adjoining sewer lift station that services the public rest rooms. I understand that the US Army Corps of Engineers is unwilling to extend the lease for these uses and as a result the City Council is considering replacing with portable restrooms and permitting food trucks to service the area. During my time at Jetty Villas I have observed a number of problems with the operation of the park and therefore I am writing with my opinion of the best course of action. I believe there are two problems

that must be resolved.

First, the City should not accept the Corps of Engineers decision not to continue the lease arrangement for the Sand Castle and the lift station. Both of these amenities are desirable for an active park and meet the standard of best in class for such a facility. Replacing the food service with food trucks or public bathrooms (with a dedicated sewer line) with porta johns is not a step in the right direction and is not in keeping with the many fine public amenities that the City is blessed with. The fact that the Corps is unwilling to approve an extension should be the subject of discussion with our Federal legislators (local Congressman and US Senators) Our representatives are more than willing to participate in such a process and will provide the support needed with such an entrenched bureaucracy. The Corps is a federal agency and is under their purview. I understand the Corps desire to remove structures in the flood zone but this is counterintuitive and does not meet a normal cost/benefit analysis nor is this good public health policy. I therefore urge the City to schedule a meeting with our Federal representatives to discuss a path to keeping the Sand Castle and the adjoining lift station open. I also ask that public representatives from Jetty Villas be present to provide support.

Secondly, the park is, with apologies to Dickens, the best of places, and the worst of places. Humphris provides many fine amenities to the community that I support and encourage including access to the Jetty, access to the beach, a public place to enjoy the Gulf views and our stunning sunsets. All of these are laudable uses. I believe the best answer to this problem is a change in the hours when the park is in public use. It is my understanding the park is open until midnight. I suggest changing park hours to 9:00 or perhaps 10:00 pm. (If an exception is necessary for fishermen and/or Crows Nest employees I agree). I also recommend that our Police Department take a proactive role in patrolling the park to both enforce the change in hours and the state's public drinking laws.

Thank you for your consideration of my suggestions and ideas. We all appreciate your service to the community and the many thankless hours you put in on our behalf.

We share the concerns about the proposed changes at Humphris Park expressed by our friends and neighbors in the Jetty community. Long before we moved to the Jetty Villas, Humphris Park was a special place that we visited often with our parents to watch the sunset, walk to the end of the jetty, and watch the birds, dolphins, and manatees. Over the years and now as Jetty residents, we have experienced the increased traffic and noise, and most notably the party atmosphere that takes over at night. Too many cars, trucks, and motorcycles, driving too fast, with music blaring at its loudest make crossing Tarpon Center Drive for a walk or an evening at the Crow's Nest a hazard. This affects not only those of us who are Jetty residents, but the many who bike or run or walk to the Jetty everyday to simply enjoy this unique access to the Gulf and the inland waterway.

Mr. Hanna

Thank you for your correspondence. There are a lot of rumors circulating about the future of the jetty. One rumor is that we plan to replace the current bathrooms with porta-a-poties. That is not correct, and was never suggested by the City administration. The Army Corps of Engineers (ACOE) owns the right-ofway on which Anita's Sandcastle is located. They have wanted the building removed for 20 years, but were also aware of a long-term lease between Anita's and the City. That lease expired in 2015. Since that time, we have allowed Anita's to continue to operate on a month-to-month basis while we reengage with the ACOE to determine our options. According to the ACOE, the most serious safety risk to the existing building is the lift station and sewer line connected to the bathrooms. We are now exploring options with ACOE, our engineers, and area permitting agencies for removing the lift station from its current site and relocating the bathrooms to a safer location. However, the bathroom models were are envisioning are not port-a-poties. We have researched contemporary portable restroom systems that are comparable in size and amenities to the existing restrooms. They typically have ceramic fixtures, flush toilets, fresh running water, sinks, are ADA accessible, and in our situation, they would be connected directly to a sewer line. In function and appearance they resemble the existing stationary restrooms. The significant difference is that they would not reside on the ACOE right-of-way, and could be removed from the Jetty if we were threatened with a hurricane or other serious weather.

The mobile vendor food service was suggested as an option to maintaining a food service on the Jetty for the benefit of the public. It is unlikely under current state and regional permitting guidelines that we would be able to construct a new permanent building on the Jetty. A defined portable food vendor site was conceived as a solution in the event we are required to remove the existing Anita's Sandcastle building. We are working with ACOE to get a final determination.

Other unfounded rumors I have seen in print about the City's plans for the Jetty: paving the Jetty with asphalt, bringing music bands to the Jetty, serving alcohol on the Jetty – all untrue, and never suggested by the City administration.

We will keep the public informed of progress regarding the future services at the Jetty. Thank you for your expressed concern

- There was never an intention to place "port-a-poties' at the Jetty but that rumor has persisted. My interpretation of that term is a relatively confining non-flushing fiberglass cubicle. What has been suggested is a transportable full-sized restroom suite. The models examined have ceramic or porcelain fixtures with fully functioning running water. . Some have air conditioning. The number of individual restroom units in the systems we have examined range from four to eight. The units are ADA accessible. The system would be directly connected to the City's wastewater system and have flush toilets. The only noteworthy distinction between the existing restrooms and the suggested portable system is that in the event of a severe storm or hurricane warning the transportable system could be disconnected and moved to a safe location to eliminate the risk of storm related damage and potential wastewater pollution.
- The mobile vendor food service was proposed as a means of maintaining a food service at the Jetty in the event that Anita's Sandcastle has to be removed the assumption being that there is a public desire for continuing food service at the Jetty. The determination of whether the current building has to be removed is being made by the property owners- the Army Corps of Engineers. We are working with our local agents to determine if and when the building must be removed.
- The building itself is composed of two metal boxes connected internally. The restrooms and deck were added to the frame along with the current exterior finish. Initial examination of the interior suggests that twenty years of salt air deterioration to the metal infrastructure has weakened the building and would make it difficult, if at all possible, to move. If it has to go it is probable that the building would be demolished. Also, it is unlikely, under federal and state current regulatory constraints, that a new permanent structure would be allowed on the Jettythat is the rationale for suggesting portable restrooms and food service- to maintain what appears to be popular amenities

No decisions have yet been made concerning the restrooms or food service. Thank you again for your comments

Dear Mr. Mayor, Council, and City Manager,

My family and I have been part of the Venice community for many decades as owners at Bahia Vista and original owners at Jetty Villas #22 1585 Tarpon Center Drive. My sister attended Venice High School for a time and we are proud of Venice and it's history and look forward to being part of its future.

I would like to voice my concern about the proposals regarding Anita's Sandcastle and the changes to the park area at the Jetty and the impact those proposals will have on the Venice community. Anita as well is a valuable asset to Venice. When I'm at her facility, I always hear new visitors to Venice as well as regulars comment on what a welcoming, warm and unique attraction it is to the area. Anita herself fosters this feeling and makes everyone feel part of her family.

I have read many of documents concerning the supposed violation of the Federal Right of Way and have the following concerns and challenges:

- It seems the claim of right of way is rather far-fetched since the documents don't seem to indicate objections when the facility was created.
- Why is the similar facility across the Intercoastal not being required to take the same action?
- Why can't the current facility simply be moved to the center of the area where the current picnic area is or in any case out of the right of way which, if I am reading the documents correctly, is 50 feet from the waterway.
- If the current proposal is adopted, it will be within 20 feet of the Jetty Villa property. If the 'portapotties' and food trucks lead to any destruction of our property or increase of

- rodent or insect infestation, we will have grounds for legal action I believe. Any encroachment or trespass of park visitors will lead to more frequent calls to the police.
- Who will be determining what vendor truck will be allowed on the property?
- Who will be responsible for maintaining the 'portapotties'? It would seem to be the responsibility of the City which would be an increase of cost.
- In view of the fact that the current park regulations concerning dogs, drinking, speed, closing time and smoking in the park are not enforced at all, I would assume these proposed 'portapotties' and vendor trucks would not be supervised either. Anita is very responsible and proud of her participation in the park and the current facility and the hours she is open reflects that pride and sense of responsibility.

My family and I frequently walk the Jetty and enjoy Anita's and consider it part of our Venice experience as do many others. I would respectfully request that any changes deemed necessary would take into consideration the park neighbors and the Venice community. Many in Jetty Villa are permanent residents and vote in the Venice area. We will all be observing future actions with great interest.
