- 6. Special Event Details: Sun Fiesta 2016 is in its 44th year of celebrating the fall season for tourists and residents alike and is truly a Venice tradition. The theme this year is "Celebrate America at Sun Fiesta 2016"; a salute to our troops and veterans. Sun Fiesta's dates are October 21, 22 and 23 (rain dates are October 28, 29 and 30) and it will be held in downtown Venice, Centennial Park. There is something of interest for each member of the entire family. Attendees will enjoy an annual parade, bed races, Miss Sun Fiesta pageant, free live entertainment and music, a huge variety of foods and drinks, arts and crafts vendors, free children's activities, the Young Marines Pancake Breakfast, and silent auction at the Gazebo. We also receive a lot of help from organizations and businesses that volunteer their time. The Venice Art Museum runs an art project in the Kids area. Home Depot employees come to teach a craft project to the children. Target Stores sends employees to help with the parade. Venice High School, through its Interact group, sends students to help in our Coke and Water booths and it's Best Friends Club, helps sell stickers. Finally, there is no admission fee.

- 9. Past Results: When Women's Sertoma took over Sun Fiesta in 1993, we inherited a debt of \$30,000. We paid that debt off in three years and have been making a profit ever since. Thankfully, through smart planning and budgeting, we've cleared more money each year although our costs have certainly risen. Our attendance has averaged 30-40,000 over the three days. We've seen an increase in attendance from outside the Venice area due to our increased print media exposure (some paid advertising, but many through public relations

efforts such as articles in the AAA Magazine and "Gulf Coast Living Venice" magazine. The Sun Fiesta Guide, produced by the Venice Gondolier is inserted into the Wednesday issue before our event and is also distributed at Sun Fiesta. We've been featured on the local ABC television station. Our impact on the immediate businesses near and around Centennial Park is evident. Retailers have commented on increased traffic in their stores and restaurants. We receive a lot of support also from the community: Venice Main Street and the Venice Chamber supports us; businesses display our flyers and place ads in our Sun Fiesta guide, and hotels offer discounted accommodations to participants such as our food and arts and crafts vendors.

We always strive to work with local suppliers for such items as tents, electricity, generators, port-o-potties, ice, water, golf carts, signing, banners, and advertising. Also to note is that we offer a special rate to other Non-Profits in the Venice area to exhibit at Sun Fiesta so that they can create awareness of what they do. Some of the non-profits, such as Sertoma Club of Venice and the Masons sell food and keep their profits to benefit their own charitable giving causes. Others who have been with us for years are: Habitat for Humanity, Boy Scouts, SPARCC, and Venice Heritage. We couldn't do Sun Fiesta without the help of our volunteers (family and friends of members), and as mentioned in Point #6 Groups like Target, Young Marines and Interact.

Once we've paid all of our obligations, we return back to the community <u>all</u> of the profits from Sun Fiesta and other smaller fundraisers that we might hold throughout the year. So far in 2016 we have given approximately \$50,000 to local charitable organizations and scholarships. The list of recipients is attached.
