SUBJECT: Approval of Continuing Contracts for RFQ 3033-16 Coastal Engineering /

Professional Engineering Services

Background:

At the request of the Engineering Department, Procurement has solicited a Request for Qualifications (RFQ) for Coastal Engineering / Professional Engineering Services in accordance with Chapter 287.055 Florida Statutes, the Consultants' Competitive Negotiation Act (CCNA).

On July 12, 2016, five (5) proposals were received. All the proposals were deemed "responsive" to the requirements of the request for qualifications. On July 27, 2016 the evaluation review committee met to review, discuss, and score the proposals. The proposing firms were ranked, and a recommendation of award to the top three (3) ranked firms was posted on July 27, 2016.

Staff has negotiated continuing contracts with the top three (3) ranked firms: Atkins North America, Inc., CB&I Environmental and Infrastructure, Inc., and Taylor Engineering, Inc. with no guarantee of contract amount, for an initial term of three (3) years with the option for two (2) one-year renewals. Separate Work Assignments (WA) will be issued for each project.

Requested Action:

Approval of Continuing Contracts for RFQ 3033-16 Coastal Engineering / Professional Engineering Services with the top three (3) ranked firms for an initial term of three (3) years with the option for two (2) one-year renewal periods.

City Attorney Review:

The City Attorney has reviewed and approved this agreement.

The Risk Manager has reviewed this agreement and finds no risk management objections.
