GUIDELINES FOR COMMUNITY REINVESTMENT PROGRAM APPLICANTS

GENERAL INFORMATION

On May 9, 2006, the Board of County Commissioners (the "Board") adopted Ordinance No. 2006-027, codified as Article VIII, Chapter 38 of the Sarasota County Code (the "Code") and Resolution No. 2006-109, which created the Community Reinvestment Program (the "Program") and the Program's Application Guide, respectively. On September 21, 2015, the Board adopted Ordinance No. 2015-064 which amended some elements of the Program. The Program provides a reasonable, quantifiable and prudent funding mechanism for public entity redevelopment activities within Sarasota County.

The Program provides opportunities for County investment in specific projects of a governmental entity that are in furtherance of the public interest and are consistent with that entity's redevelopment program, master plan or adopted policy. The County's method of investment in a proposed project is at the discretion of the Board, determined on a project-specific basis. Generally, investment will be either pay-for-performance or reimbursement. An upfront lump-sum payment will be considered only if there are irrevocable financial commitments to the Project from other funding sources. This *PROGRAM APPLICATION GUIDE* is designed to assist applicants through the Program application process.

PROCEDURES FOR APPLYING FOR THE COMMUNITY REINVESTMENT PROGRAM

Any governmental entity requesting funding from the Program (the "Applicant") must first submit two (2) original applications with appropriate attachments to:

Upon receipt of the application, Sarasota County staff shall review, and within ten (10) days of receipt shall, notify the Applicant of any deficiencies.

Complete applications shall be presented to the Board at a regularly scheduled Commission meeting. Applicant will be notified of the date and time of the meeting. The Board shall consider only projects that are part of a municipal or County redevelopment program, master plan or policy adopted by the governmental entity in furtherance of the public interest. The following projects are eligible for the Program consideration:

- 1) Acquisition of real property
- Design, engineering, site preparation and construction of public improvements, including but not limited to, roads, streetscaping, water and wastewater systems, and other public amenities or facilities, which are necessary to the success of the project
- 3) Renovation, redesign, alteration of expansion of existing public facilities or public improvements

The Board shall consider investing in eligible projects that preserve and strengthen existing communities, based upon the extent to which the project meets the following criteria:

- 1) Applicant has completed relevant project feasibility studies, plans, surveys and financial analyses
- 2) Promotes one or more of the following sustainable growth goals:
 - a. Commitment to local procurement and local hiring
 - b. Capital investment in areas experiencing underinvestment
 - c. Sustainable transportation strategies
 - d. Land use walk score
 - e. Minimize environmental impacts
 - f. Sustainable water strategies
 - g. Sustainable building strategies
 - h. Balance jobs with housing
- 3) Provides an economic stimulus to the community
- 4) Leverages funding from other public and private sources

BOARD CONSIDERATION Upon receipt of the complete Program Application, OBED staff shall verify the amount of Program funding available for the current fiscal year and schedule the Application for consideration by the Board as a Discussion item at the next available County Commission meeting. The terms and conditions of the funding, the method of investment, the schedule of reports and other relevant terms shall be set forth in an interlocal Agreement with the municipal applicant or by Board resolution if applicant is the County. The investment amount for each project shall be based on the amount of available funds, estimated project value, the eligibility criteria and any other factors determined by the Board to be in the public interest.
