Mr. Woodman spoke on community's response to project, relocating project to another site, and disagreement with project.

The motion carried by voice vote 5-2 with Ms. Anderson and Mr. Fraize opposed.

Recess was taken from 10:12 a.m. until 10:28 a.m.

Mayor announced this is a quasi-judicial procedure.

Ms. Stelzer read the ordinance by title only.

Mr. Daniels returned to the dais at 10:30 a.m.

Mayor Holic opened the public hearing.

Mr. Persson questioned council on ex-parte communications and conflict of interest. There were no conflicts of interest. Mayor Holic and Mr. Daniels noted site visits, and Ms. Anderson noted she had a brief general discussion about this item with an audience member.

No written communication was received.

Scott Pickett, senior planner, being duly sworn, presented the city's case to include zoning amendment, summary of proposed rezone petition, aerial photograph, existing zoning map, proposed zoning map, consistency with the comprehensive plan, consistency with future land use map designation, land use compatibility, staff planning analysis, and staff summary and findings of fact.

Mr. Pickett responded to council questions to include units per acre, dwelling units, maximum density per acre, commercial units, planning commission's support, concurrency, property access, sidewalk widening, residents input, density compatibility, notices to residents, height standards, pedestrian safety, and comprehensive plan height and density restrictions.

Mr. Persson clarified restriction changes to the comprehensive plan and noted council must review application under the current comprehensive plan.

Mr. Pickett responded to council questions regarding public street access and zoning density.

Ronald Siegrist, 490 Hauser Lane, Venice, being duly sworn, spoke on his background, planning commission's request for council's approval, the Venetian Seaboard Master Plan, utilization of infrastructure, response to zoning petition, affordable work force housing, number of units requested, and consistency with future land use.

Discussion continued on work force housing, ability for applicant to provide affordable work force housing, site plan drawings and design, wetland designation, and inlets.

Mr. Persson clarified the city's zoning restriction.

Discussion continued on density bonus and identifying affordable housing.

Don O'Connell, 500 Hauser Lane, Venice, being duly sworn, noted his support of the applicant and spoke on concerns with stipulations placed on affordable work force housing.

Mayor Holic closed the public hearing.

A motion was made by Council Member McKeon, seconded by Council Member Daniels, that Ordinance No. 2016-16 be approved on first reading and scheduled for final reading.

Discussion continued on egress, pedestrian safety, property advantages, and guarantee for developing work force housing.

16-2259 Public Works Director John Veneziano: Proposed Tarpon Statue at W. Blalock/Arboretum (10 min.)

Mr. Veneziano spoke on the Venice Area Beautification Inc. (VABI) statue proposal, corridor proposal, and approval by the Parks and Recreation Advisory Board.

Discussion followed on statue maintenance and repairs, dolphin statue at the Jetty, statue donations, art placement, longevity of statues, statue design, statue capacity at Blalock Park, statue location, and funding.

Mr. Veneziano responded to council questions regarding budget for artistic fixtures and maintenance, proposed statue location and view, and obtaining resident input.

A motion was made by Council Member Gates, seconded by Council Member McKeon, to approve Item No. 16-2259. The motion carried by voice vote 6-1 with Mr. Daniels opposed.

<u>16-2260</u> Airport Director Mark Cervasio: Airport Layout Plan and Request for Council Approval of the Interim Airport Layout Plan (10 min.)

Mr. Cervasio provided a brief history on the skydiving request and spoke on the Federal Aviation Administration (FAA) flight risk assessment, identified risks and mitigation measures, compatibility with the airport, airport layout plan, operator frequency, publications, parachute drop zones, and operator access routes.

Discussion followed on safety, site considerations, drop zone designated areas, location and monitoring of sheriff's helicopter, t-hangars, peak airport operation time, transient pilots, safety measures, and FAA flight risk assessment.

Mr. Cervasio responded to council questions regarding projected landing area, city's flight assessment, requirement for a radio on aircrafts, and city's liability.

Mr. Jackson responded to council questions regarding the city's liability, and Mr. Persson explained sovereign immunity.

Discussion ensued on location of drop zones, pilot radio communication, safety concerns, command pilot's responsibility, FAA's responsibility in supervising command pilots, commercial pilots, and near miss counts.

Paul Hollowell, 628 Armada Road South, Venice, spoke on support of skydiving at the airport and FAA safety recommendations.

Peter Wassylenko, 3540 Becker Road, Venice, spoke on support of skydiving operations.

Mr. Cervasio responded to council questions regarding participation of other skydiving companies, and noted the maximum number of jumps allowed per year per operator.

A motion was made by Council Member Daniels, seconded by Council Member Gates, to approve Item No. 16-2260. The motion carried by voice vote 6-1 with Mayor Holic opposed.
