SUBJECT: Approval of Continuing Contracts for RFQ 3032-16 Engineer of Record / Civil

Engineering Services

Background:

At the request of the Engineering Department, Procurement has solicited a Request for Qualifications (RFQ) for Civil Engineering Services in accordance with Chapter 287.055 Florida Statutes, the Consultants' Competitive Negotiation Act (CCNA).

On July 14, 2016, eighteen (18) proposals were received. All the proposals were deemed "responsive" to the requirements of the request for qualifications. On September 29, 2016 the evaluation review committee met to review, discuss, and score the proposals. The proposing firms were ranked, and a recommendation of award to the top seven (7) ranked firms was posted on September 30, 2016.

Staff has negotiated continuing contracts with six (6) of the seven (7) ranked firms: Stantec Consulting Services, Inc., Jones Edmunds & Associates, Inc., King Engineering Associates, Inc., Kimley-Horn, Atkins North America, Inc., and ZNS Engineering, with no guarantee of contract amount, for an initial term of three (3) years with the option for two (2) one-year renewals. Separate Work Assignments (WA) will be issued for each project. Staff was unable to negotiate an Agreement with Jensen and Group (JAG) due to dissolution of the firm. Articles of Dissolution are attached.

Requested Action:

Approval of Continuing Contracts for RFQ 3032-16 Engineer of Record / Civil Engineering Services with the top six (6) ranked firms for an initial term of three (3) years with the option for two (2) one-year renewal periods.

City Attorney Review:

The City Attorney has reviewed and approved the agreements.

Risk Management Review:

The Risk Manager has reviewed the agreements and finds no risk management objections.
