### III. Approval of Minutes

## IV. Public Hearings

ARB 233 W VENICE AVE - HISTORIC

<u>16-5151</u> Installation of an Awning to the Front Elevation of the Building

Owner: Smulron LLC Agent: Discount Awnings

Mr. Jackson announced this was a quasi-judicial hearing and questioned board members on ex-parte communications and conflicts of interest. There were no conflicts of interest and Mr. Hind noted site visit.

Mr. Steketee opened the public hearing.

Mr. O'Neill, being duly sworn, spoke in regards to the staff report, awning, and the applicant's absence.

Discussion took place regarding the meeting preference, offer recommendation regarding color, guidelines of awnings, color in language, covered enclosure, signage, awning not serving a purpose, building being on the national historic register, historic preservation board (HPB) reviewing this item.

Mr. Hagler spoke in regards to the awning, national historic structure, and the board having the authority to approve the item.

Discussion ensued regarding the building being an historic structure, awning color, quality, character, aesthetics, location, awning being signage, history of the store, new owner and changes, interior awning, awning sizes and shapes, color issue, zoning, requirements, backlighting, and the suggestion of the applicant resubmitting application for a different color.

Mr. Steketee closed the public hearing.

A motion was made by Mr. Hind, seconded by Mr. Barrick, that based on the presentation, the Architectural Review Board moves to Continue Application No. ARB 16-5151 and that the owner be present, with the sign to be a different color for submission. The motion carried by voice vote unanimously.

Mr. Shrum provided an update on staff comments, ARB not having enough information from the applicant to approve item, project being on the local register, process through the building department and HPB, city council discussion on the topic, overlapping duties, discussions on the comprehensive plan, neighborhood workshops, review of comments, topics, composing a draft of the plan, timeframe of plan, and providing input from ARB.

Discussion took place regarding ARB's responsibility, input and desires, timeframe, special meetings, ARB workshop, availability of the comprehensive plan draft for review, land and development code of plan, building height, section on transition, obtaining the draft for all boards, timeline, workshops, final draft timeframe, comments from planning commission, discussion with city council, eliminating parts of the plan on specific topics, land development code, regulatory aspects, working with consultant, mixed use districts, public meetings, and the role and input from ARB.
