III. Approval of Minutes

<u>17-2448</u> Minutes of the November 18, 2016 Regular Meeting

A motion was made by Mr. Codella, seconded by Mr. Whittaker, that the Minutes of the November 18, 2016 meeting be approved as written. The motion carried by voice vote unanimously.

IV. New Business

<u>17-2450</u> Process for Local Register Nomination

Discussion took place regarding the process of the local register nomination, applicants, waiting on the ordinance and comprehensive plan to be completed, nomination form, attending planning commission meetings, comments to planning commission, request of the comprehensive plan draft, process of draft plan copies, the consolidation of the architectural review board (ARB) with the historic preservation board (HPB), draft of ordinance, certified local government (CLG) standards, board not being quasi-judicial, local register, combining two advisory boards in the comprehensive plan, how the two boards will be merged, suggestion of having Mr. Shrum speak at the next meeting, and the mergeingof the two boards not being in the comprehensive plan.

<u>16-2414</u> Circus Car Proposal for the Venice Train Depot

Carolyn Redlin, Venice Heritage Historical Society, provided an update on the circus train car to include location, delivery, video of the transport, project phases, payment of project, contract with Uniglide, date of the celebration, completion dates and penalties, and the interior design committee.

Discussion took place regarding additional fundraising, newpaper article not mentioning Venice as a role regarding the circus, termination of live circus arts, the usage of the Barnum and Bailey Circus emblem for the circus train car, Venice's celebration of the circus, press release of circus and clown college, and historical society and realtors involvement.

16-2415 Staff Liaison Update

Mr. Hagler spoke in regards to candidates for the curator position, contingency of museum personnel, and the position being non-bargaining.

16-2412 Certified Local Governments

Greg Watkins, 320 Pedro Street, spoke in regards to implementation of tax incentives and landmarks, position of board, all board members in favor of tax incentives, criteria, current landmark recognitions, and the board being more proactive.

Discussion took place regarding tax incentives, bureaucratic circle, comprehensive plan revision, projects not having any actions, helping homeowners protecting their properties, historical properties, timeline and criteria, support from the mayor and city manager, number of historical houses, clarity of program, application charge, process involvement, responding to the application, changes, plan being voluntary, city and county tax incentives for keeping the exterior of homes historic, Nolen Plan elements, and benefits.

Discussion continued regarding tax incentives, historic structures, criteria, and critique of requirements.
