RESOLUTION NO. 2016-33

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA, ELECTING TO USE THE UNIFORM METHOD OF COLLECTING NON-AD VALOREM ASSESSMENTS FOR MORE THAN ONE YEAR LEVIED IN VENICE, FLORIDA; STATING A NEED FOR SUCH LEVY; PROVIDING FOR THE MAILING OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA, as follows:

SECTION 1. AUTHORITY. This Resolution of the City of Venice, Florida (the "City") is adopted pursuant to the Charter of the City of Venice, Florida, Sections 166.021 and 197.3632, Florida Statutes, and other applicable provisions of law.

SECTION 2. FINDINGS. It is hereby ascertained, determined and declared as follows:

- (A) The City Council of the City of Venice, Florida (the "City Council"), is contemplating the imposition of special assessments, sometimes referred to as non-ad valorem assessments, to provide annual funding for the provision of fire protection services and facilities.
- (B) The City Council intends to use the uniform method for collecting such non-ad valorem assessments for the cost of providing fire protection services and facilities to property within the City which is specially benefitted thereby and as authorized by Section 197.3632, Florida Statutes, which will allow such assessments to be collected annually, commencing in November 2017, in the same manner as provided for ad valorem taxes.
- (C) The City Council held a duly advertised public hearing for the purpose of considering the adoption of this Resolution, proof of publication of such hearing being attached hereto as Exhibit A.

SECTION 3. UNIFORM METHOD OF COLLECTING NON-AD VALOREM ASSESSMENTS.

- (A) Commencing with the ad valorem tax bills issued in November, 2017, and continuing each year thereafter, the City hereby announces its intention to use the uniform method of collecting non-ad valorem assessments for more than one year as authorized in Section 197.3632, Florida Statutes, to fund the provision of fire protection services and facilities. Such non-ad valorem assessments shall be levied throughout the entire incorporated area of the City, a legal description of which is attached hereto as Exhibit B and incorporated herein by reference.
- (B) The City hereby determines that the levy of such assessments is needed to fund the cost of providing such fire protection services and facilities.
- (C) Adoption of this Resolution is solely for the purpose of complying with the statutory requirements that the City publicly announce to the Florida Department of Revenue, the Sarasota County Property Appraiser and the Sarasota County Tax Collector before March 1, 2017 that it may levy non-ad

valorem assessments and use the uniform method of collection. Adoption of this Resolution shall not be deemed to commit or require the City to impose any assessments.

- (D) The Mayor and City Manager are hereby authorized and directed to take such further actions as may be required by Section 197.3632, Florida Statutes, for collection of the assessments pursuant to the uniform method, including executing reimbursement agreements on behalf of the City with the Sarasota County Property Appraiser and Sarasota County Tax Collector pursuant to Section 197.3632(2), Florida Statutes. The reimbursement agreements shall be in substantially the forms set forth in Exhibit C attached hereto, together with such changes as shall be approved by the Mayor in consultation with the City Attorney, such approval to be conclusively evidenced by the execution thereof by the Mayor
- (E) Upon adoption, the City Clerk, or her designee, is hereby directed to send a copy of this Resolution by United States mail to the Florida Department of Revenue, the Sarasota County Property Appraiser and the Sarasota County Tax Collector by March 10, 2017.

SECTION 4. CONSTRUCTION; EFFECTIVE DATE. This Resolution shall be liberally construed to effect the purposes hereof and shall become effective immediately upon adoption.

CITY OF VENICE NOTICE OF INTENT TO USE UNIFORM METHOD OF COLLECTING NON-AD VALOREM ASSESSMENTS AND NOTICE OF PUBLIC HEARING

The City Council ("City Council") of the City of Venice (the "City") hereby provides notice to all owners of lands located within the boundaries of the City, pursuant to Section 197.3632(3)(a), Florida Statutes, of its intent to use the uniform method of collecting non-ad valorem assessments to be levied within the City to fund the annual costs of providing fire protection services and facilities. The uniform method authorizes the collection of such assessments on the ad valorem property tax bill mailed by the Sarasota County Tax Collector each November. The City Council will consider adoption of a resolution stating its intent to use the uniform method of collecting the assessments commencing in November 2017 and continuing each year thereafter, as authorized by Section 197.3632, Florida Statutes, at a public hearing on December 13, 2016 at 9:00 a.m. in the Council Meeting Room at 401 West Venice Avenue, Venice, Florida 34285. Such resolution will state the need for the levy and will contain a legal description of the boundaries of the real property subject to the levy. A copy of the proposed form of resolution is on file at the Office of the City Clerk located at 401 West Venice Avenue, Venice, Florida 34285.

In the event any person decides to appeal any decision by the City Council with respect to any matter relating to the consideration of the resolution at the above-referenced public hearing, a record of the proceeding may be needed and in such an event, such person may need to ensure that a verbatim record of the public hearing is made, which record includes the testimony and evidence on which the appeal is to be based. 






EXHIBIT C FORM OF TAX COLLECTOR AND PROPERTY APPRAISER REIMBURSEMENT AGREEMENTS

AGREEMENT

THIS AGREEMENT made and entered into this ___ day of _____, 2017, by and between the City of Venice of Sarasota County, Florida, whose address is 401 West Venice Avenue, Venice, Florida 34285, referred to as the "City" and Barbara Ford-Coates, Sarasota County Tax Collector, a constitutional officer of the State of Florida, whose address is 101 S. Washington Blvd., Sarasota, Florida, 34236, hereinafter referred to as "Tax Collector".

WITNESSETH:

WHEREAS, the City is authorized to impose ad valorem assessments and by Resolution has expressed its intent to use the uniform method of notice, levy, collection and enforcement of such assessments, as authorized by Section 197.3632, Florida Statutes; and

WHEREAS, Section 197.3632 (2), Florida Statutes, provides that the City shall enter into a written agreement with the Tax Collector for reimbursement of necessary administrative costs incurred in implementing the uniform methodology law; and

WHEREAS, Section 197.3632 (7), Florida Statutes, provides that the City shall bear all costs associated with any separate notice in the event the Tax Collector is unable to merge a non-ad valorem assessment roll to produce the annual tax notice; and

WHEREAS, Section 197.3632 (8) (c), Florida Statutes, provides that the City shall compensate the Tax Collector for actual costs of collecting non-ad valorem assessments;

NOW, THEREFORE, for and in consideration of the foregoing, including mutual terms, covenants and conditions herein contained, the parties do contract and agree as follows:

ARTICLE I Purpose

The purpose of this Agreement is to establish the terms and conditions under which the Tax Collector shall collect and enforce the collection of those certain non-ad valorem assessments levied by the City pursuant to Section 197.3632. Florida Statutes.

ARTICLE II Term

This Agreement shall become effective upon execution and shall continue from year to year unless terminated by the City of Venice pursuant to Section 197.3632(6), Florida Statutes.

ARTICLE III Compliance With Laws and Regulations

The parties shall abide by all statutes, rules and regulations pertaining to the levy and collection of non-ad valorem assessments and any ordinances or resolutions promulgated by the City not inconsistent with, nor contrary to, the provisions of Section 197.3632, Florida Statutes, and Section 197.3635, Florida Statutes, and any subsequent amendments to said statutes, and any rules duly promulgated pursuant to these statutes by the Department of Revenue.

ARTICLE IV Duties and Responsibilities of the City

The City agrees, covenants and contracts to:

- (a) Reimburse the Tax Collector for actual costs incurred in the collection and enforcement of the applicable non-ad valorem assessment under the new uniform law, pursuant to Section 197.3632 (2), Florida Statutes, to include, but not be limited to, those costs associated with personnel, forms, supplies, data processing, computer equipment, postage and programming.
- (b) To pay for or alternatively to reimburse the Tax Collector for any separate tax notice necessitated by the inability of the Tax Collector to merge the non-ad valorem assessment roll certified by the City pursuant to Section 197.3632 (7), Florida Statutes;
- (c) By 15 September of each calendar year, the chairperson of the governing board of the City, or his or her designee, shall officially certify to the Tax Collector the non-ad valorem assessment roll on compatible electronic medium, tied to the property identification number. The City shall post the non-ad valorem assessment for each parcel on the said non-ad valorem assessment roll and shall exercise its responsibility that such non-ad valorem assessment roll be free of errors and omissions. The City shall inform the Tax Collector, as well as the Property Appraiser and the Department of Revenue by 10 January of each calendar year in which it intends to discontinue using the uniform method of collection and enforcement of the applicable non-ad valorem assessment.
- (d) The City agrees to cooperate with the Tax Collector to implement the uniform method of notice, levy, collection and enforcement of each non-ad valorem assessment, pursuant to, and consistent with, the provisions of Sections 197.3632 and 197.3635, Florida Statutes, and any successor provisions and the applicable rules promulgated by the Department of Revenue and any successor rules.

ARTICLE V Duties of the Tax Collector

- (a) The Tax Collector shall merge all rolls, prepare a collection roll and prepare a Notice of Ad Valorem Taxes and Non-ad Valorem Assessments pursuant to Sections 197.3632 and 197.3635, Florida Statutes, and any successor provisions, and any applicable rules, and any successor rules, promulgated by the Department of Revenue, and in accordance with any specific ordinances or resolutions adopted by the City, so long as said ordinances or resolutions are not inconsistent with, or contrary to, the provisions of Sections 197.3632 and 197.3635, Florida Statutes, and any successor provisions, and any applicable rules or successor rules promulgated by the Department of Revenue.
- (b) The Tax Collector shall collect and enforce the non-ad valorem assessment of the City as certified to the Tax Collector no later than 15 September of each calendar year on compatible electronic medium, tied to the property identification number for each parcel.
- (c) The Tax Collector agrees to cooperate with the City in implementation of the uniform method of collecting and enforcing non-ad valorem assessments pursuant to Sections 197.3632 and 197.3635, Florida Statutes, and any successor provisions and applicable rules. The Tax Collector shall not accept any such non-ad valorem assessment roll that is not officially certified to the Tax Collector by 15 September of each calendar year on compatible electronic medium tied to the property identification number.
- (d) If the Tax Collector discovers errors or omissions on such roll, she may request the City to file a corrected roll or a correction of the amount of any assessment and the City shall bear the cost of any such error or omission.

- (e) If the Tax Collector determines that a separate mailing is authorized pursuant to Section 197.3632 (7), Florida Statutes, and any applicable rules promulgated by the Department of Revenue, and any successor provision to said law or rules, the Tax Collector shall either mail a separate notice of the particular non-ad valorem assessment or shall direct the City to mail such separate notice. In making this decision, the Tax Collector shall consider all costs to the City and to the taxpayers receiving the separate mailing as well as the adverse affect on the taxpayers receiving multiple notices. If such a separate mailing is affected, the City shall bear all costs associated with the separate notice for the ad valorem assessment.
- (f) The Tax Collector shall, at each distribution of funds, deduct 1 1/2% of the assessments collected to reimburse the actual costs incurred. On or before September 30th of the year following the assessment year, the Tax Collector shall compare total actual costs expended to the total amount deducted from the distributions. The City will be reimbursed or billed for any difference, subject to the provisions of section 192.091(2)(b)2, Florida Statutes.

WITNESSETH

WHEREAS, the LOCAL GOVERNING BOARD certifies that is has established a non-ad valorem, assessment district (Fire Assessment) and is authorized to impose Non-Ad Valorem assessments and by Resolution 2016-33 has expressed its intent to implement the UNIFORM METHOD FOR THE COLLECTION AND ENFORCEMENT OF NON-AD VALOREM ASSESSMENTS, as authorized by §197.3632, F.S.

NOW, THEREFORE, for and in consideration of the foregoing, including mutual terms, covenants and conditions herein contained, the parties do contract and agree as follows:

ARTICLE I Purpose

The purpose of this agreement is to establish the terms and conditions under which the PROPERTY APPRAISER and the LOCAL GOVERNING BOARD shall comply with the provisions set forth in §197.3632, F.S.

ARTICLE II Term

This Agreement shall become effective upon execution and shall continue from year to year unless terminated by the LOCAL GOVERNING BOARD or the PROPERTY APPRAISER.

ARTICLE III Compliance with Laws and Regulations

The parties shall abide by all statutes, rules and regulations pertaining to the levy and collection of Non-Ad Valorem assessments and any ordinances or resolutions promulgated by the LOCAL GOVERNING BOARD not inconsistent with, nor contrary to, the provisions set forth in §197.3632, F.S. or other applicable Florida laws.

ARTICLE IV <u>Duties and Responsibilities of the LOCAL GOVERNING BOARD</u>

The LOCAL GOVERNING BOARD agrees, covenants, and contracts to:

Provide notice to the PROPERTY APPRAISER of any Ordinance and Resolution creating a new Non-Ad Valorem District or amending an existing Non-Ad Valorem District.

Every Non-Ad Valorem District operating under the LOCAL GOVERNING BOARD wishing to participate in the annual Notice of Proposed Property Taxes and Proposed or Adopted Non-Ad

Valorem Assessments shall submit to the PROPERTY APPRAISER data in the format and by the date specified by the PROPERTY APPRAISER.

Reimburse the PROPERTY APPRAISER, when Administrative costs apply.

ARTICLE V <u>Duties and Responsibilities of the PROPERTY APPRAISER</u>

The PROPERTY APPRAISER agrees, covenants, and contracts to:

Provide information electronically to the Non-Ad Valorem Assessment Districts pursuant to §197.3632(3)(b) F.S. for each parcel within the boundaries of each district. Data requirements and frequency of transmission will be mutually agreed by the Non-Ad Valorem Assessment District and the PROPERTY APPRAISER.

Include Non-Ad Valorem assessments in the annual Notice of Proposed Property Taxes and Proposed or Adopted Non-Ad Valorem Assessments.

When Administrative costs apply, send the LOCAL GOVERNING BOARD an estimate of Administrative costs for budgeting purposes by June 1st of each year.
