INVOCATION AND PLEDGE OF ALLEGIANCE

Ms. Stelzer offered the Invocation followed by the Pledge of Allegiance led by Council Member Daniels.

I. RECOGNITION

<u>17-2515</u> 20-year Service Award, John Parrish, Electrical/Maintenance Technician, Public Works

Mr. Cautero presented this award.

II. AUDIENCE PARTICIPATION

Chief Tom Mattmuller, Venice Police Department, spoke on hosting a law enforcement memorial event on May 16, 2017.

Jackie Mineo, Sovrano Road, spoke on the Venice Library to include the proposed name, donations, county ordinance and county library systems.

Lueanne Wood, 800 Golden Beach Road, expressed her concern with the renaming of the library.

Discussion took place regarding renaming the library, lease terms, legal

issues, not being informed of the name change, and being provided updates in the future.

Mike Sunderland, Auburn Woods HOA president, expressed his concerns regarding the new public safety facility.

Gaetano Candido, 109 Auburn Woods Circle, expressed his concerns regarding the new public safety facility.

Richard Packman, 303 Casa Del Lago Way, expressed his concerns regarding the new public safety facility and referenced an email he sent to city council.

Sarabeth Kalajian, Sarasota County Libraries and Historical Resources, spoke on the progress of the new library to include demolition of the current facility and outreach to business owners, county and city staff working on draft agreement, and stated the county will be seeking city council support of the agreement.

Discussion took place on emails being received by city council regarding construction of a new fire station.

	Ms. Weeden spoke to the design and permitting phase, project costs, monitoring throughout the project, and impact inclusion in scope designs, and responded to council questions regarding providing information to business owners and residents, impacts on businesses, providing council with the conceptual plan of the promenade pathway design, road paving, and funding sources.

Ms. Stelzer read the ordinance by title only.

Mr. Cautero opened the public hearing.

Ms. Stelzer stated no written communication has been received and no one signed up to speak.

Mr. Cautero closed the public hearing.

A motion was made by Council Member Daniels, seconded by Council Member McKeon, that Ordinance No. 2017-04 be approved and adopted.

Mr. Lavallee spoke to the purpose of the initiative and language restrictions that inhibit the inclination to construct a more enhanced and attractive enclosure, and suggested that Section 54-53 of the ordinance be amended to state "Minimum standards provide that screens and enclosures shall be constructed of vinyl fencing or vinyl coated chain link with vinyl slats except properties in an architectural control district shall comply with the requirements set forth in the Architectural Guidelines

Handbook. In lieu of vinyl fencing or vinyl coated chain link with vinyl slats screening, enhanced architectural designs including vegetative buffering, masonry facing, and other aesthetically upgraded fencing may be substituted, as approved by the city".

A motion was made by Council Member Daniels, seconded by Council Member Gates to amend the ordinance as stated by Mr. Lavallee.

The amendment carried by voice vote unanimously.

Ms. Stelzer read the resolution by title only.

A motion was made by Council Member Daniels, seconded by Council Member Fraize, that Resolution No. 2017-04 be approved and adopted.

Discussion took place regarding educating locally opposed to addressing the state, gaining local support, environmental concerns, impact on sea turtles, affirmation of home rule, future discussions, the need for clarity on details, concerns with bag fees, procedure for follow up with the state, and working with state representative.

Ms. Stelzer confirmed the city clerk's office will send a letter with the resolution to state representatives with no follow up planned.

Tom Jones, Economic Advisory Board (EAB) chair, commented on the resolution being sent to representatives, the EAB taking responsibility of communication with state representatives and EAB discussion regarding steps the city could take to assist in solving environmental problems.

Discussion continued regarding consistency with the county, requesting the mayor mention the issue at Council of Governments to possibly obtain support of other municipalities, and single stream landfill not being financially viable.

The motion carried by the following vote:

<u>17-2520</u> Direct the City Manager to Contact the Sarasota County Administrator for a Homeless Update Presentation (Daniels)

Discussion took place regarding previous updates from Wayne Applebee, new county administrator procedures, discussion between the City of Sarasota and Sarasota County on Housing First versus essential emergency shelter, and having a country representative provide an update on workforce housing and homelessness.

Mr. Lavallee spoke to the process for obtaining county updates.

Discussion ensued regarding consideration of a police holding facility.

A motion was made by Council Member Daniels, seconded by Council Member Gates, that the motion be amended to include workforce housing. The amendment carried by voice vote unanimously. The motion as amended carried by voice vote unanimously.

Mr. Cautero noted the mayor is in Washington, D.C. discussing the city's legislative priorities with representatives.

Mr. Persson had no report.

City Clerk

Ms. Stelzer had no report.

City Manager

Mr. Lavallee commented on previous council discussion regarding Charlotte Harbor National Estuary Program (CHNEP) membership, presentation by CHNEP representative at previous council meeting, and dues allocated in the current budget.

Discussion took place regarding previous discussion to remain in the program with Mr. Fraize as the liaison and the value of the program.

A motion was made by Council Member Daniels, seconded by Council Member Gates, to continue the city's membership with CHNEP and for Mr. Fraize to be the city's liaison. The motion carried by voice vote unanimously.

Mr. Lavallee reminded council of student government day on March 6, 2017.

Discussion took place regarding ongoing dispute between the Venice Golf Association and utilities regarding reclaimed water and city council being provided an update at the March 28, 2017 or April 11, 2017 meeting.

Mr. Persson stated that he will follow up with Attorney Steve Chase.

Mr. McKeon reported on upcoming meetings and his attendance at Venetian Golf and River Club town hall meeting with one of the topics being affordable housing.

Council Member Gates

Ms. Gates reported on Dean Calamaras' fossil collection to be placed within the city and requested an update on the library design phase.

Mr. McKeon spoke to Bob Vedder potentially facilitating communication with the county regarding history of the library.

Discussion continued regarding the city being included in the process and the need to verify concerns of constituents.

Ms. Gates continued her report on Economic Development Council (EDC) providing a presentation to city council.

Council Member Cautero

Mr. Cautero reported on the historic preservation board (HPB) discussion regarding historic landmark designation applications and Venice MainStreet and Venice Area Beautification, Inc.'s clay planters project on Miami Avenue.

In response to council questions, Mr. Lavallee spoke on staff meetings with county staff and confirmed that council is requesting direct communication updates from the county.

Discussion continued on pocket park signage.
