
There is a 10 acre parcel of land immediately adjacent and to the north of the 29.9 acre parcel that is the subject of affordable rental apartments. The owner is asking \$2,130,000 and I am not sure the land is still available as it may have a contract on it. However, if the land is still available (I have the owners name but choose not to put it on the server) I would request that you contact the county and see if they have funds to purchase it in the Florida Forever account. I think, if we were able to get the land, we would be able to make a park out of it with park impact fees, This is an excellent location for a park on the northeast side of the city - far superior to the AJAX property and large enough for a dog park and pickle ball.
