SUBJECT: Approval of Contract with A2 Group, Inc. in the amount of \$440,112 for City of Venice Parking Lot, Site 3

Background:

At the request of the Engineering Department, Procurement has solicited sealed bids for Invitation to Bid, ITB 3047-16, City of Venice Parking Lot, Site 3 Re-bid. On November 22, 2016, seven (7) bids were received.

Upon evaluation of the bids staff recommends award to A2 Group, Inc., of Port Charlotte, Florida, as the lowest responsive and responsible bidder, in the amount of \$440,112.09. A Notice of Intent to Award was issued on December 13, 2016.

The Engineering Department has reviewed the bid responses and concurs with this recommendation.

Requested Action:

Approval of the attached contract with A2 Group, Inc. in the amount of \$440,112.09 and grant authorization for the Mayor to execute the contract.

The Risk Manager has reviewed this document and finds no risk management objections.

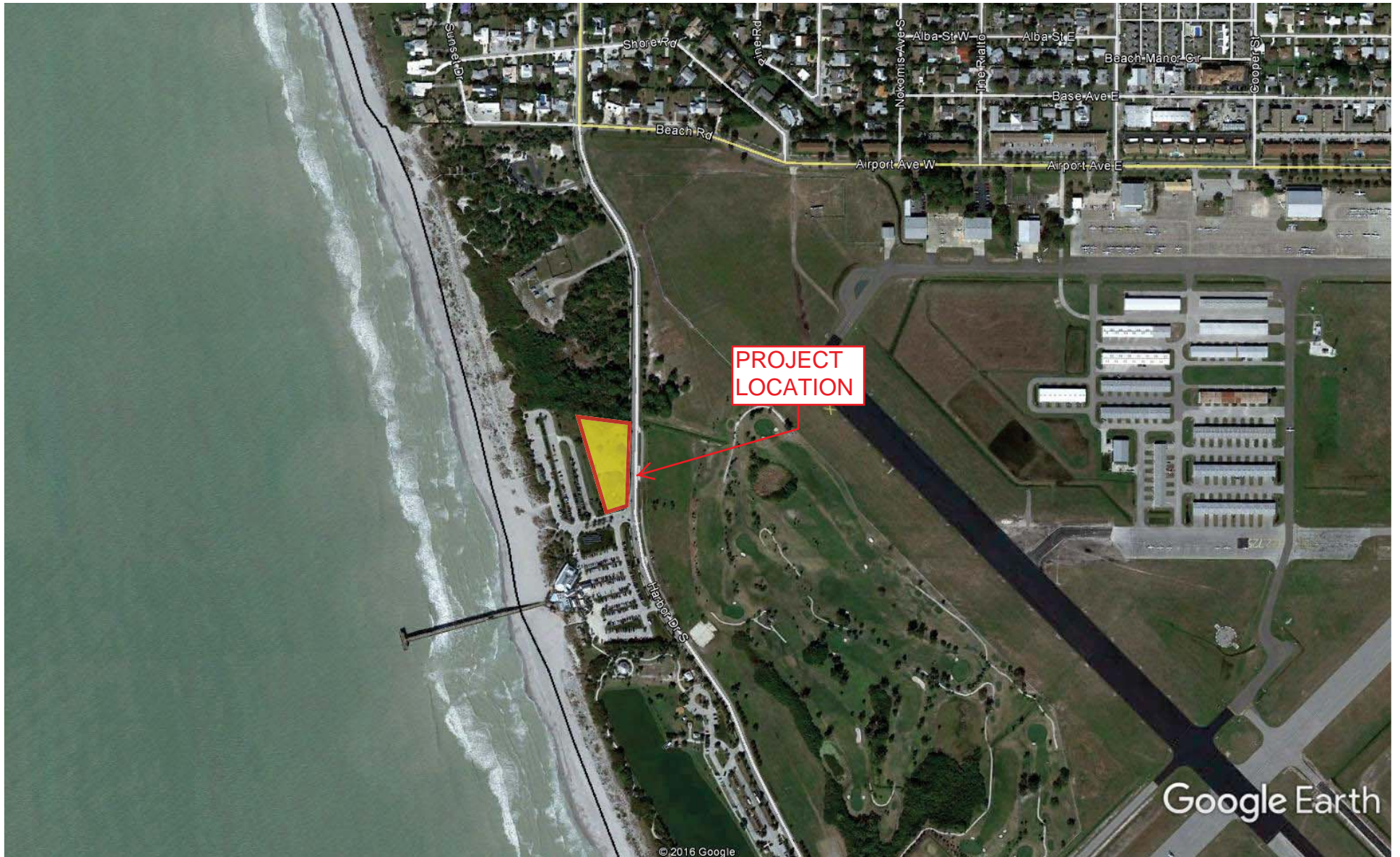
