The Site Location.

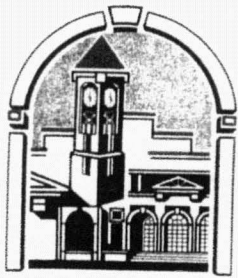

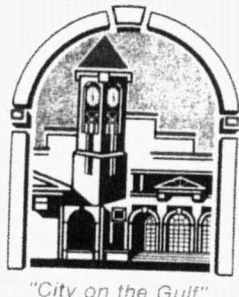
