# Meeting Minutes Public Art Advisory Board

Wednesday, June 14, 2017 3:30 PM Council Chambers

#### I. Call to Order

A Regular Meeting of the Public Art Advisory Board was held this date in Council Chambers at City Hall. Chair Jean Trammell called the meeting to order at 3:30 p.m.

#### II. Roll Call

Public Works Director John Veneziano and Assistant City Clerk Heather Taylor.

## III. Approval of Minutes

17-2725 Minutes of the March 8, 2017 Regular Meeting

Ms. McCullough questioned whether James Hagler and Mayor Holic should be listed under also present, and verbiage annotating her arrival at the meeting, and suggested alternate verbiage for the last paragraph on page one.

This item was continued until the next meeting.

#### IV. New Business

17-2732

Mary Schwass, Office Manager, Venice Area Beautification Inc. (VABI): Proposal for a Mural to be Painted on the Green Parrot Building on Founder's Way (10 mins)

Lynn Moseley, Vice President, Venice Area Beautification Inc. (VABI), spoke to the proposal from Joseph Barron, and resurfacing the wall and responded to board questions regarding maintenance and touch-ups as needed, VABI contract, and insurance.

Discussion took place regarding the provided photos displaying what the mural would look like at the proposed location, possible modifications to obtain a Venetian theme, blending with surrounding objects, size of the mural, and lighting.

A motion was made by Ms. McCullough, seconded by Ms. Dietz, that Item No. 17-2732 be recommended for approval to city council. The motion carried by voice vote with Ms. Valencic opposed.

#### 17-2757

Request from Venice Area Beautification, Inc. to Place a Bronze Statue at the Southwest Corner of W. Venice Avenue and Nokomis Avenue

Bob Vedder displayed photos to show the art and flower combinations currently downtown, spoke to the proposed statue to include location, discussions with public works, having a raised anchored foundation, completion date, and availability of statue and responded to board questions regarding compatibility between the Maria and Sophia statues and possible alternate locations.

Lynn Moseley, Vice President, VABI, spoke to statues placed by the beach needing to be able to withstand the elements.

Discussion continued regarding whether a statue holding a sea shell is appropriate for downtown, ability for pedestrians to stand near the statue for photos, maximum number of statues to be proposed and using younger pedestrians taking selfies to promote the city.

A motion was made by Ms. McCullough, seconded by Ms. Dietz, that Item No. 17-2757 be recommended to city council for approval. The motion carried by voice vote unanimously.

#### 17-2733

Council Directive for the Historic Preservation Board, in Partnership with the Mariemont Preservation Foundation, to Select Appropriate Nolen Influenced Communities and Invite them to Join the Association of Nolen Communities and Direct the Public Art Advisory Board, in Partnership with an Appropriate Board from the Village of Mariemont, Ohio to Design a Logo and Identification Sign to be Used for the Association of Nolen Communities, to be Routed Through the Historic Preservation Board and Mariemont Preservation Foundation Prior to being Sent to Either Council for Approval

Mr. Veneziano responded to board questions regarding identification of the board from Mariemont.

Discussion took place regarding establishing a point person on the board to solicit further information, calls to artists through other organizations, sign specifications to include size, verbiage and logo, duties of a point person, additional research on John Nolen, timeline for completion, and coordination between the boards.

Ms. Moscatelli agreed to starting a call to artist, distributing to organizations and collecting them back to present to the board.

Discussion continued regarding receiving input from Mariemont, Mr. Veneziano contacting Mariemont for a point of contact, and options for

acknowledgement of the volunteer chosen to create the sign.

A motion was made by Ms. Dietz, seconded by Ms. Valencic, to approve Ms. Moscatelli to start a call to artists to find a viable simple John Nolen logo and present to the public art advisory board to forward to Mariemont. The motion carried by voice vote unanimously.

17-2524 Agreement for Commission of Public Artwork/Artist Contract Discussion

Discussion took place regarding the need for a contract for the acceptance of donated art and one for commissioned art, review of the current public art policy, procedure for contract for temporary display of public art, and content of the sample contracts.

Mr. Veneziano spoke to involvement of the city attorney.

Ms. Trammell recommended this be discussed at the next meeting.

Discussion took place regarding whether the city currently has a public art contract.

This item was continued to the next meeting.

Discussion took place regarding updating the policy.
