A lot of issues with the proposal need the Stakeholder's process to insure "fairness" and most important, "AVOID LITIGATION!"

WE CAN'T AFFORD TO ADOPT SOMETHING NOW AND FIX IT LATER.

Some of the contentious issues involve:

The Consultant was not familiar with building value calculations developed by Sarasota County and major flaws have resulted (including the wrath of Bill Furst):

- Condo values are inflated with the value of common amenities and common land.....a last
 minute fix to compensate using "average land value" in Venice is ripe for litigation and not
 previously tested in the Court system
- Adding "Extra Features" to "Building Value" inflates that figure for residential's with \$ for nonstructural items such tennis courts and swimming pools
- Adding "Extra Features" to "Building Value" inflates that figure for non-residential's with \$
 for parking lot pavement and other nonstructural features

Let's not burden the Churches and Salvation Army with this fee....appears they can be excluded and should be

Fire Fees in Florida have a shadow of involvement with litigation and Stantec has been tested as taxpayers have paid exorbitant legal fees to get these cases resolved.....

- Cape Coral involved \$24 million of fees collected and put on hold for years as the case moved through the Courts all the way up to the Supreme Court
- Cooper City involved claims for a \$2.5 million refund of fees that also dragged through the Court system
- The Citizens of Venice do not want to be dragged through another Court Case like the Sunshine Law Violation.....we can't afford the legal fees and time delay

Going the Stakeholders route will guarantee "fairness" and "AVOID LITIGATION!". You will have folks like:

- Lee Lichtle a dedicated "watchdog" who will make sure the condo owners will be protected
- Tony Pinzone, my neighbor, and avid activist, who will make sure the interests of the manufactured home owners are looked after
- And when I was on the Group, we had a representative from: Bird Bay, Single Family
 residents, and for non-residentials, a representative from the Hospital, and Mike Pachota of
 Sharkeys

They have worked together to refine many controversies regarding financial proposals, and a similar group worked to get the Building Permit process streamlined.

Major Funds:

Fund 401 – The Airport Fund will dip into reserves during FY18, anticipating a reduction in working capital of \$567,708 for the year. The FY18 budget includes capital projects costing \$3,305,000, which will be financed with grants totaling \$2,613,000 and operating revenues/reserves of \$692,000. Ending reserves (working capital) are projected at \$1.9 million, which is 37% of budgeted expenditures/uses.

Fund 421 – The Utilities Fund will dip into reserves during FY18, anticipating a reduction in working capital of \$4,799,335 for the year. The FY18 budget includes capital projects costing \$18,578,500, which will be financed with State Revolving Fund loans totaling \$6,450,000 and operating revenues/reserves for the balance. Ending reserves (working capital) are projected at \$22.0 million, but include \$9.2 million in restricted assets (which can only be spent on "expansion" projects). Excluding restricted assets, net working capital is projected to end the year at 36% of budgeted expenditures/uses.
