

Mayor and Council,

I'm wading through the latest from Stantec....9/1/17 Revised Resolution (from 11 pages in the original resolution vetted at the 8/16 info sessions, presented at the 8/21 Hearing, and considered again at the 8/28 Special Council Meeting to the 23 page resolution now on the 9/7 Public Hearing agenda......12 additional pages of legalize obviously in response to the public outcry and an obvious invitation to litigation) .....

and the 9/1/17 Final Addendum by Stantec (apparently augmenting the detailed memo of 8/25/2017 from Linda Senne thru the City Manager attempting to mitigate the objections of condominium owners who clearly have a legitimate claim that the current proposal does not stand the test of being "fairly and reasonably apportioned among the properties that receive the special benefit"; there is also another test that the process must also be "fair and equitable", which requirement is also not met.

In the "Final Addendum", it should be noted that the average value of residential property is \$14.54 per square foot. The concept of an "average value for Venice property is at best, an enormous stretch. Attached is a sort of the Stantec Table 1 showing a range in their data from \$4.35 per square foot to \$37.24 per square foot, from which an average of \$14.54 was derived and then used for land credit adjustments for the Tier 2 calculation for condominium. Stantec's data for single family land was expanded as shown on the attached with a resulting range of \$6.37 per square foot to \$69.98 per square foot.

The higher number within the added set represents beachfront property. Many of the condominium units in the City mix are high rise along the beach as well as the Mike Miller Complex on the Intracoastal.

Stantec claims "Such a revision to the treatment of condominium parcels in Tier 2 reflects a reasoned and logical approach to addressing the specific circumstances and parcel configuration present in the City based upon available data, and in our estimation, is reasonable in light of the specific circumstances and parcel configuration present in the City."

Reasonable it may or may not be, however the test is fair and equitable! Which it is not

Is it fair and equitable to use an average land value of \$14.54 per square foot for a condominium unit located on the beach when beachfront property has a value of \$69.98 per square foot? Is it fair and equitable to use an average land value of \$14.54 per square foot for a condominium unit located in Mike Miller's High-Rise Complex on the Intracoastal when upscale property has a value of \$37.22 per square foot?

#### NO! It is not fair and equitable!

The Final Addendum Fix as a last-minute effort to solve the fatal flaw identified by condominium owners does not solve the issue.

As we head into the 9/7 Final Hearing, it is clear that the ground for a class action has been set including the condominium owners, mobile home owners in resident owned parks, and commercial activities like the owners of the St Andrews Surgical Site Complex. These folks have made it clear they will take any and all necessary steps to protect their interest, including initiation of proper steps in a court of competent

jurisdiction to secure relief within twenty (20) days from the date of the City Council's adoption of this Final Assessment Resolution.

Please vote No on the Fire Fee Proposal and send the entire funding issue of the Fire Dept. to the Stakeholders Group

Mayor & City Council Members:

Unfortunately I will be out of the country when the above captioned hearing is held so I am writing to provide my input. As I indicated at the initial public informational meeting that was held at the Venice Community Center, I support the Fire Department and want to ensure that they have the tools they need to provide the community with the vital and necessary services. However, I am also outraged at the attempt by the city to enact a City Fire Fee without concurrently disclosing this proposed fee at the time the City proposed the two bond referendums on the ballot last year. There is just no excuse for this lack of transparency. What is perhaps the most outrageous is that this has been a known issue, kicked around for years by prior councils and yet the public was not advised when they were voting to approve the bond issues that an even bigger financial impact was looming and would soon be imposed upon them......and that this was one over which they would not opportunity to veto in a referendum. In addition, the methodology chosen to establish the fee is flawed in many ways, is inequitable and does not include a very important component: the input from the stakeholders, we the paying public.

Perhaps the most egregious aspect of the proposal, aside from the timing and lack of transparency is that while there has been a great deal of rationalization as to why the money is needed, I do not see where the council has done what every individual has to do regarding their own finances: sit down and decide what has to be cut to pay for this capital expenditure. In other words, as was asked at the forum, where are the proposed budget cuts to make the budget more revenue neutral? Yes, there are a lot of "needs" in the budget, but there are also a lot of "wants".....both need to be looked at and perhaps some hard choices made to see where they rank relative to the needs of the Fire Department. Why should the budget considerations that every citizen has to deal with on a personal level not be a consideration in this circumstance? When faced with financial challenges, as individuals, we don't have the luxury of just deciding that we need more money ......unless we're willing to go into debt..... which makes us think twice about whether the money is really needed now and re-evaluate our priorities and perhaps sacrifice our immediate needs or cut expenses elsewhere. Why should this issue be any different. Has the council looked at what can be cut from the budget to fund the Fire Department capitol expenses? All of us individually have to find ways to live within our means.....nor should the city be exempt from having to do so as well. Yes, the financial situation may not be of the current council's making, but like everyone else who has ever worked in management, no one cares about what happened in the past because those people are long gone and it's now your responsibility to balance the budget and make it work.

It also did not go unnoticed by many of us that the building occupied by the police department which, ostensibly is in such deplorable condition and supposedly too expensive to fix, is now going to be occupied by the Public Works Department.......clearing the way for the city to sell between five and seven

acres in the Seaboard district for redevelopment. Why isn't the money from this sale used to fund the Fire Fee instead of the 1% sales tax that residents also generously agreed to extend and which will be in place for another 7 years? What happens at the end of the 7 years.....are we again going to be asked to extend the sales tax to fund an ever increasing budget? Why are the proceeds from the sale of that land not being used instead of, as was reported, to fund some other as yet unnamed project? One thing I know for sure is that there are few if any of us who thought these funds would be used to perpetuate an increasing and ballooning budget.

I respectfully ask the council to vote against imposing the City Fire Fee until such time as other alternatives, including but not limited to a re-examination of the budget to redirect existing funds is explored, a fairer and more equitable methodology is developed, total transparency, a more thorough and thoughtful plan that will not be unlimited and unending and one that more fairly spreads the financial burden. This is not a question of whether the needs of the Fire Department are justified......we all know and want to support them. But we all also have to learn to live within our means and that includes our public entities.
