To the members of the City of Venice Council:

We are citizens of the City of Venice, residing in the North-West side of the Venetian Golf and River Club (VGRC) community.

Based on the latest evolution of the situation in the "industrial park", located North-West of our community, we have a new proposed location for a sound barrier, which will shield more than 500 residents from the continuous noise generated by the factories located in the "industrial park".

As you probably know, two (2) more factories have been established in the "industrial park", getting the total number of factories up to five (5). One of the new company, "McLeod Land Services" is made up of two or more plants, crush concrete, cement mixed, etc. They are located right across the lakes north from our community. The noise generated at this location will travel without any restrictions over the water and it will be amplified by the water and open land. Combined with the other factories noises, it will be unbearable.

We have no protection, absolutely zero, just few trees which have no effect in absorbing the noise and we are directly exposed to the tremendous noise generated at all these factories every day and sometime nights, which basically ruin our long desired quiet life in Florida.

Please see the attachment with the new proposed berm location. This location can shield us from noises generated at all five (5) factories.

The sound barrier should be a dirt berm or concrete fence at least 15 feet tall or above home's roof level, to be efficient, otherwise it will be a waste of time and resources.
