

NOTICE IS HEREBY GIVEN THAT THE CITY OF VENICE PLANNING COMMISSION WILL HOLD A PUBLIC HEARING ON TUESDAY. DECEMBER 5, 2017 AT 1:30 PM IN CITY HALL COUNCIL CHAMBERS, 401 WEST VENICE AVENUE, VENICE, FLORIDA, TO CONSIDER SITE AND DEVELOPMENT PLAN AMENDMENT PETITION NO. 17-09SP AS DESCRIBED BELOW:

PROPOSED SITE & DEVELOPMENT PLAN 17-09SP: PROPOSED CONSTRUCTION OF A THREE-STORY, 64-UNIT SKILLED NURSING FACILITY, AND TWO FIVE-STORY INDEPENDENT LIVING BUILDINGS WITH A COMBINED TOTAL OF 46 UNITS. COMBINED, THE THREE BUILDINGS HAVE A TOTAL FLOOR AREA OF APPROXIMATELY 189,000 SQUARE FEET.
