Mayor Holic called the meeting to order at 9:00 a.m.

Mayor Holic offered the Invocation followed by the Pledge of Allegiance led by Mr. Lavallee.

#### **II. PUBLIC HEARINGS**

#### ORDINANCES - FIRST READING

ORD. NO. 2018-04

An Ordinance of the City of Venice, Florida, Amending the 2010 City of Venice Comprehensive Plan, Land Use and Development Chapter, Future Land Use and Design Element, Map Flum-24 Village on the Isle (VOTI) Campus, and Amending the 2017-2027 City of Venice Comprehensive Plan, Appendix 5 - Areas of Unique Consideration, Map Flum-24 Village on the Isle (VOTI) Campus, by Revising the VOTI Campus Boundary and Adding 0.99± Acres to the VOTI Campus Involving Properties Located at 800 and 900 South Tamiami Trail (Parcel Identification Nos. 0430-07-0007

and 0430-02-0018); Providing for Conflict with other Ordinances; Providing for a Severability Clause; and Providing an Effective Date

Ms. Taylor read the ordinance by title only.

Mayor Holic opened the public hearing.

No written communication was received and no one signed up to speak.

Mr. Pickett provided a presentation and spoke on the request, proposed small-scale map amendment, existing and proposed improvements, aerial photograph and existing land use, future land use map (FLUM), review of plan amendment, and summary findings.

Greg Roberts, representing petitioner, requested to postpone petitioner's presentation. Discussion followed on continuing with the hearing and Mr. Roberts agreed.

Joel Anderson, Village on the Isle (VOTI) Chief Executive Officer (CEO), spoke to project, tax exempt bond, VOTI, nursing facility replacement plan, application, comprehensive plan amendment, land swap with Emmanuel Lutheran Church, and borders.

Mr. Roberts commented on the land swap parcel and the FLUM.

Discussion followed on the parking area, landscape and trees, waiver, and comprehensive plan amendment.

No one signed up to speak.

Mayor Holic closed the public hearing.

A motion was made by Vice Mayor Daniels, seconded by Council Member Newsom, that Ordinance No. 2018-04 be approved on first reading and scheduled for final reading. The motion carried by the following vote:

#### CC 17-01WV

Approve Development Order 17-01WV, Waiver of Venetian Urban Design District Standards in Relation to a Proposed Off-Street Parking Facility, Village on the Isle & Emmanuel Lutheran Church, 800 and 900 South Tamiami Trail

Mayor Holic announced this is a quasi-judicial procedure and opened the public hearing.

Mr. Persson questioned council on conflicts of interest and ex-parte

communications. Mr. Newsom, Mr. Cautero, and Mayor Holic noted site visits and no communication. There were no conflicts of interest.

No written communication was received.

Mr. Pickett, being duly sworn, provided a presentation and spoke on summary of requested Venetian Urban Design (VUD) waivers and existing and proposed improvements, and responded to council questions regarding the church parking lot and enhancing the gateway.

Discussion took place regarding enhancing the city's gateways.

Mr. Pickett spoke on the aerial photograph and existing land use, FLUM, proposed small-scale map amendment, existing zoning map, requested waivers on Emmanuel Lutheran Church and the south portion of the VOTI Campus, review of requested VUD waivers, comprehensive plan consistency and compliance with the land development code (LDC), and summary findings.

Discussion followed regarding building setback requirements and lot coverage.

Dean Paquet, Kimley-Horn and Associates, Inc., being duly sworn, spoke to project applications, waivers, building setback and orientation, covered walkway, parking area, land swap, and landscaping to include buffer.

Greg Roberts, representing petitioner, being duly sworn, commented on the landscaping.

Discussion followed on campus and church access points, landscaping, and north side walkway height.

Joel Anderson, VOTI CEO, being duly sworn, spoke to campus security.

No one signed up to speak.

Mayor Holic closed the public hearing.

A motion was made by Vice Mayor Daniels, seconded by Council Member Cautero, to approve Item No. 17-01WV.

Mr. Persson clarified council's motion is to approve based upon the evidence of record, that the waiver will be in the interest of the public safety, health, or welfare of the citizens of Venice.
