CALL TO ORDER

Mayor Holic called the meeting to order at 9:00 a.m.

VII. NEW BUSINESS

C. COUNCIL ACTION/DISCUSSION

18-3138 Request Approval to Secure Funding Immediately for a School Resource Officer (Holic)

Sergeant Leisenring spoke on the School Resource Officer (SRO) program to include officer training.

Lieutenant Hill requested funding for an additional SRO and noted the need for a training manager.

Discussion followed regarding Sarasota County school district resources and replication of services, coordinating with the School Board and sheriff's office, SRO funding, SRO's obligation to charter and public schools, SRO training and availability, training manager position, the School Board's plan to harden schools, protecting the youth, proposed state legislation, and a floating SRO.

Mr. Lavallee noted the budget will need to be amended.

A motion was made by Mayor Holic, seconded by Vice Mayor Daniels, to authorize funding for the police department to fulfill protection of our schools. The motion carried by voice vote unanimously.

There was no objection by council to address Item No. 18-3136 next.

18-3136 Discuss Request from Habitat for Humanity to Sell Two-Acre Parcel

Mr. Lavallee spoke to Habitat for Humanity's request and intent.

Recess was taken from 10:03 a.m. until 10:11 a.m.

Dee Danmeyer, Habitat for Humanity Executive Director, spoke regarding the organization's intent, residential property development, certificates of occupancy, and property zoning.

Bill Ahern, Habitat for Humanity Board of Director Vice President, spoke on affordable housing, property use and development, and sale proceeds.

Discussion followed regarding the cost of building affordable housing, building within city limits, and property value.

Mr. Daniels left the meeting at 10:21 a.m.

Discussion continued on building within city limits, city contributions, benefitting city residents, warranty deed, and land reverting back to the city.

Mr. Lavallee spoke to deed restrictions.

Discussion followed regarding property use and development, extension of time frames, and staff reviewing the property's zoning.

There was council consensus for staff to review the current zoning of the property.

A. PRESENTATIONS

18-3135

City Engineer Kathleen Weeden: Downtown Roadway Corridor Improvements Scope Discussion to Address Bids Received Above Approved Budget Appropriation

Ms. Weeden spoke regarding bids, funding sources, one cent sales tax, road bond, alternatives to include deducting flower basket poles, median electrical, conduit for lighting poles, and adding stormwater funds, irrigation and landscaping, project boundary, drainage project, discussion with downtown merchants, suggestion to change detour schedule, and requested council direction.

Discussion took place on Nokomis Avenue, downtown merchants, reducing project scope, road closures, pipe replacements, drainage, stormwater funds, bids, protecting the best interest of the business community, Venice Avenue median fence, Florida Department of Environmental Protection (FDEP) monitored sites, postponing drainage project, bond funds, project budget, and contingency.

Bob Vedder, Venice Area Beautification Inc., noted concern with watering hanging baskets.

A motion was made by Council Member Fiedler, seconded by Council Member Cautero, for Ms. Weeden to proceed with Option No. 2, recommending to FDOT to reject all bids and remove Nokomis Avenue drainage project. The motion carried unanimously by voice vote.

VI. UNFINISHED BUSINESS

<u>18-3116</u> Mayor Holic: State of the City

Discussion took place regarding the post office transfer station, knowledge sharing between council members, beach parking, growth, petitions for development in the northeast area, land development code (LDC) to include lot coverage, affordable housing, impact fee methodology, park and mobility fees, neighborhood parks and connectivity, draft parks master plan, including beach parking and impact fees on the next meeting agenda, state referendum on homestead exemption, requesting Mr. Lavallee to have Bill Furst make a presentation to council, Argus Foundation letter regarding homestead exemption, and knowing estimated future impact to the city.

B. ORDINANCES

ORD. NO. 2018-10

An Ordinance of the City of Venice, Florida, Amending Ordinance No. 2008-10, Which Adopted a Pre-Annexation Agreement with SJMR Limited Partnership, a Florida Limited Partnership, and Sandra S. Hurt, as Trustee of the Carlton J. Hurt Trust; by Adopting a Second Amendment to the Pre-Annexation Agreement, to Remove a Provision that Required Havana Road be Improved and Extended from Border Road to Laurel Road as a County/Public Road; Providing for Conflicts Herewith; Providing for Severability; and Providing for an Effective Date

Ms. Stelzer read the ordinance by title only.

Jeffery Boone, representing the applicant, commented on the ordinance and requested council's approval.

Pat Wayman, 3071 Border Road, showed a conceptual plan of the Hurt property and spoke regarding supporting city businesses, protecting bicyclists, and entrances to Border Road.

Mr. Boone commented on sidewalks and bike lanes on Border Road and Havana Road connectivity.

A motion was made by Council Member Newsom, seconded by Council Member Gates, that Ordinance No. 2018-10 be approved on first reading and scheduled for final reading.

Discussion took place regarding bike lanes on Border Road, providing an alternate access road connecting Laurel Road to Border Road, Havana Road, and the comprehensive plan.

The motion carried by the following vote:

Discussion followed regarding cones placed in city right-of-ways and cars parked in bicycle paths.

Mr. Daniels returned to the meeting at 1:03 p.m.

COUNCIL ACTION/DISCUSSION - Continued

<u>18-3137</u> Discussion on Dual Check Valve (Holic)

Discussion took place on dual check valve permit fees.

Mr. Vargas spoke to state mandate, installation by licensed plumbers, and providing council with a plan on testing, repair, and replacement within 30 days.

18-3139 Review Proposal on Parks Interlocal Agreement in Preparation of Joint Meeting with Sarasota County

Discussion took place regarding changes to Pinebrook Park, assessing conditions of local parks, the city being responsible for capital improvements and park assessments, the county taking over responsibility of Wellfield Park, the city taking over responsibility of local parks, transition period, and the county's request for a deed.

Mr. Persson provided clarification on having a deed versus a lease.

Discussion continued regarding county master parks plan, providing more athletic fields, needs assessment, Pinebrook Park, having a deed versus a lease, Chuck Reiter Park, pocket parks, park assessments and repairs, city park expenditures, the city's age demographic population, Pinebrook Road reconstruction, termination of the parks interlocal agreement, obtaining a comprehensive analysis of near and long term costs, county and citizens coming to an agreement, the city taking over responsibility of the Venice Community Center (VCC), staff providing input on generating revenue to offset the VCC's operational costs, continuing discussions with the county, city's cost to maintain local parks, impact fees, the county's plan for Wellfield Park, lacrosse, residential spending, the county's parks master plan including municipalities, hiring a consultant to study the VCC, county joint partnership with the school board on playgrounds, Venetian Waterway Trail, and the capital improvement plan (CIP).

Mr. Veneziano commented on park expenditures.

Discussion continued on park assessments and maintenance, and impact fees.

Mr. Lavallee spoke to elements in the parks interlocal agreement, city's responsibility for local parks and beaches, and capital obligations.

Discussion continued regarding the parks interlocal agreement, park conditions, Chuck Reiter Park, regional parks, city maintaining a county-wide park, impact fee use, park restrooms, county master parks plan, Chuck Reiter field little league scheduling, staffing costs, transition timeframe, park maintenance costs, rescinding termination of the interlocal agreement, festival grounds, and joint meeting schedule and agenda.

Mr. Lavallee commented on the interlocal agreement, Wellfield Park, city taking over responsibility of local parks, Chuck Reiter Park, regional field criteria, and rescinding the county's termination letter.

Discussion continued on rescinding the termination of the interlocal agreement and discussing ways to improve the agreement.

Dick Longo, 295 Marsh Creek Road, commented on preserving Pinebrook Park.

Discussion continued on incorporating a timeframe in the motion, developing a better interlocal agreement, joint meeting agenda, audience participation format, and Mayor Holic requesting the county rescind the termination letter at the joint meeting.

A motion was made by Council Member Cautero, seconded by Vice Mayor Daniels, to respectfully request the county rescind the termination of the interlocal agreement related to parks and to continue discussions on a possible future agreement. The motion carried by voice vote unanimously.

Council Member Newsom

Mr. Newsom reported on the Economic Development Corporation (EDC) and planning commission meetings.
