#### V. UNFINISHED BUSINESS

A. UPDATE – INFORMATION FROM STANTEC BY CHIEF CARVEY Chief led discussion on assessment fee options. Availability (2-tier system) vs Calls for service. Council chose not to consider the calls for service method due to increased costs for ALF and other similar facilities.

Chief reported on conversation with Mike Burton of Stantec. Recommendations for considering: keep structure value, add a flat rate, and a square foot base for calculations. Note that the land leased MHPs would still not pay as much. Discussions included:

Residential vs commercial and flat rates. Exempt properties (government, non-profit)

## B. METHODOLOGY OPTIONS

Members discussed:

- Department needs, shortfalls, possible independent audit.
- Other possible options as structure value not fair on residential
- Equitability amongst users with associated risks (residents, day visitors, seasonal visitors, industrials)
- Assessment fee public feedback
- Corporations getting initial tax breaks to come into the city yet tax breaks remain and they are not paying fair proportion for fire service. They also have increased associated risks. Stantec's recommendation is to keep commercial at structure value.
- Mutual aid agreement and fund recovery. Question requested data on Venice's responding as mutual aid calls out of area (Pelican Point).
- The County charges .66 mills for Emergency Medical Services (EMS) for ambulance service. Also has an ambulance fee if transported. Venice does not receive monies.
- Funding mechanisms available for consideration.
- Millage rates maximums and annual caps, one cent sales tax funding.
- Provisions have been made for increasing staff as growth continues within city limits and surrounding communities.
- Capital replacement plan and reserves.
- Sustainability of various funding options.
