Dear Mayor & Council,

Attached are the primary documents related to Capri Isles Bridge. As you will note the bridge deficiency letter was received by Public Works on 10/5/2017 (bond was voted on 11/6/16). Upon receipt of this letter, copies of previous bridge reports were researched and FDOT was contacted for missing reports. Sarasota County was consulted to provide estimate for bridge rehabilitation up to replacement as the most conservative estimate and an opportunity presented itself to apply for State Legislature Funds for the bridge. These funds are a direct appropriation by the State Legislature passed through FDOT which

expedites the funding process. Based on conversations with MPO staff, MPO funding would put us at the end of the new 5th year and since this is an off-system bridge, the priority would be lower. Since the road segment is included in the road bond list, the surface infrastructure and related bridge repairs/upgrades were determined to be an eligible Road Bond expense by bond council. A conceptual review of the bridge condition is currently being conducted by a structural engineering firm and a better estimate of required work and cost will be available in the next few weeks.
