SUBJECT: Approval of Contract with Soto Industries, LLC d/b/a Norman Alexander Contractor in the Amount of \$169,800 for Renovation Work at the Dale Laning and Julia Cousins Laning Archives & Research Center

#### Background:

At the request of the Public Works Department/Historical Resources Division, Procurement has solicited sealed bids for renovation work at the Dale Laning and Julia Cousins Laning Archives and Research Center. On May 19, 2018, Invitation to Bid (ITB) 3086-18 was issued. On June 20, 2018, one (1) responsive and responsible bid was received.

Upon evaluation of the bids staff recommends award to the sole bidder, Soto Industries, LLC d/b/a Norman Alexander Contractor, of Punta Gorda, Florida, in the amount of \$169,800. A Notice of Intent to Award was issued on July 6, 2018.

The Public Works Department has reviewed the bid response and concurs with this recommendation.
