

**AMENDMENT NO. 1
TO AGREEMENT NO. CAC2017-0155**

This Amendment is made and entered into upon execution by both parties by and between **Sarasota County**, a political subdivision of the State of Florida, hereinafter referred to as the "**County**," and **City of Venice**, hereinafter referred to as "**City**."

WITNESSETH

WHEREAS, the County and the City entered into Agreement No. CAC2017-0155 ("Agreement") for the provision of hosting and related technology services, effective September 13, 2017; and

WHEREAS, the parties now wish to amend the Agreement

NOW THEREFORE, the County and the City, in consideration of the mutual covenants contained herein, do agree to amend the Agreement as follows:

1. The above recitals are true and correct and incorporated herein by reference.
2. The term of the Agreement is hereby renewed for a period of one (1) year, effective September 13, 2018 through September 12, 2019.
3. Replace Section 6.a. Payment of Fees in its entirety with the following:

"Annual fee for the services provided by County under this Agreement: City shall pay the County annually the amount of Three Thousand Four Hundred Ninety-Seven Dollars and Sixteen Cents (\$3,497.16). Initial payment of Two Hundred Ninety-One Dollars and Forty-Three Cents (\$291.43) is due by October 1, 2018. The remainder is due and payable in monthly installments of Two Hundred Ninety-One Dollars and Forty-Three Cents (\$291.43) each and shall be paid on the first of every month. The details of the fees are listed in Exhibit A attached and incorporated herein."

4. The Pricing for Delivered Services as of the effective date of the Amendment is attached hereto and incorporated herein as Exhibit A – Pricing for Delivered Services.
5. Except as modified herein, all other terms, covenants, and conditions of the Agreement shall remain in full force and effect.
