# Meeting Minutes Code Enforcement Board

#### I. Call to Order

A Regular Meeting of the Municipal Code Enforcement Board was held this date in Council Chambers at City Hall. Chair Robert Young called the meeting to order at 10:00 a.m.

Ms. Fernandez noted this case was dismissed.

CASE NO.Emily Wyatt, 1024 Pineland Avenue, Violation of City of Venice Code of18-381Ordinance Chapter 86, Land Development Code, Article VI, Design and<br/>Development Standards, Division 4, Off-Street Parking, Section 86-423(b),<br/>Driveway Standards; Chapter 62, Streets, Sidewalks and Other Public<br/>Places, Article III, Driveways and Curb Cuts, Section 62-62, Right-of-Way<br/>Use Authorizations and Section 62-63, Driveway Specifications

Ms. Fernandez queried board members on ex-parte communications and conflicts of interest. There were none.

Mr. Young opened the public hearing.

Mr. Davis, being duly sworn, reviewed the case to include site inspection, violations, timeframe for the owner to come into compliance, staff communication with the owner, final inspection, setback requirement, millings, site permit, and responded to board questions regarding setback requirement, area being used as a driveway, filing of site plan, staff's last contact with the owner, and corrective action needed.

Mr. Clinch, being duly sworn, noted the owner obtained a site prep permit for the pipe extension only.

Discussion followed regarding permit process, the area being used as a driveway, drainage issues, millings being higher than the neighbors property, and option for the owner to remove milling on the portion of the right-of-way and five feet from the property line.

Mr. Davis noted staff's request is to restore the original state of the property or obtain a site prep permit and approval from zoning.

Mr. Young closed the public hearing.

Discussion continued on the site prep and right-of-way permits, and area being used as a driveway.

A motion was made by Mr. Reilly, seconded by Mr. Hale, that based on the sworn testimony and evidence presented, the Board finds Respondent in violation of Sections 86-423(b), 62-62 and 62-63 of the City Code of Ordinances, and that the Respondent be given until January 1, 2019 to correct the violation by restoring the property to its original state, or receive a site prep permit to modify the driveway and a right-of-way use permit, and receive a final inspection. Should the Respondent fail to comply with this order within the timeframe set forth herein, a fine may be imposed of up to \$250.00 per day for each day the violation continues beyond the time specified herein for compliance. This case will be

heard at the January 3, 2019 Code Enforcement Board meeting beginning at 10:00 a.m. to determine if the order has been complied with and whether a fine should be imposed. The motion carried by the following vote:
