NOTICE OF VIOLATION

This is a direct violation of Venice Code of Ordinances, Subpart B, Land Development Regulations, Chapter 86 – Land Development Code, Article V. – Use Regulations, Division 2. – Resource and Conservation Zoning Districts, Sec. 86-49, Site and development plan and zoning reviews.; which states as follows:

Sec. 86-49. - Site and development plan and zoning reviews.

- (3) Certificate of zoning compliance. It shall be unlawful to use or occupy, or permit the use or occupancy, of any building, premises or both, or part thereof, hereafter created, erected, changed, converted or wholly or partly altered or enlarged in its use or structure, until a certificate of zoning compliance shall have been issued by the zoning administrator stating that the proposed use of the structure or land conforms to the requirements of this chapter. A copy of the certificate of zoning compliance shall be made part of the building permit file. Failure to obtain a certificate of zoning compliance as set out in this chapter shall be a violation of this chapter and punishable as provided by this chapter.
 - 3. You are hereby notified that you must correct the violation by removing all boats docked at 998 Laguna Drive associated with the commercial boat rental business being operated at 996 Laguna Dr.
 - 4. You will be allowed **five (5) days** from your receipt of this Notice to correct this violation. **If the violation is not corrected within the time period specified in this Notice, a Notice of Hearing will be scheduled before the CODE ENFORCEMENT BOARD.**
