

NOTICE IS HEREBY GIVEN THAT THE CITY OF VENICE PLANNING COMMISSION WILL HOLD A PUBLIC HEARING ON TUESDAY, DECEMBER 18, 2018 AT 1:30 PM IN CITY HALL COUNCIL CHAMBERS, 401 WEST VENICE AVENUE, VENICE, FLORIDA TO CONSIDER REZONE AMENDMENT PETITION NO. 18-03RZ AS DESCRIBED BELOW:

A PROPOSED AMENDMENT TO THE TOSCANA ISLES PLANNED UNIT DEVELOPMENT (PUD) TO CLARIFY THE STANDARDS FOR FRONT AND SIDE YARD SETBACKS FOR CORNER LOTS, PROVIDE AUTHORITY TO THE ZONING ADMINISTRATOR TO APPROVE MINOR MODIFICATIONS TO THE PUD, AND TO MODIFY THE PUD STANDARDS FOR THE SEPARATION OF DRIVEWAYS FROM THE EDGE OF PAVEMENT OF INTERSECTING STREETS.
