Amending Division 2. - Subdivision Design Standards, Sec. 86-232. -Minimum improvements;

Amending Division 5. - Landscaping Requirements, Sec. 86-433. - Plan approval;

Amending Chapter 74 Utilities, Article V. - Stormwater Management. Division 2. - Control and Disposal:

Amending Sec. 74-264. - Runoff of stormwater and best management practices (BMPs) for construction sites.

Written comments filed with the Planning Commission (c/o Planning & Zoning Department at the above address) will be heard and considered.
