Meeting Minutes Environmental Advisory Board

I. Call to Order

A Regular Meeting of the Environmental Advisory Board was held this date in Council Chambers at City Hall. Chair Tom Jones called the meeting to order at 1:00 p.m.

III. Approval of Minutes

<u>18-3649</u> Minutes of the October 24, 2018 Regular Meeting

A motion was made by Mr. Stone, seconded by Mr. Jones, that the Minutes of the October 24, 2018 meeting be approved as written. The motion carried by voice vote unanimously.

IV. Presentation

18-3650 Fred MacNamara and Bruce Balck: Rethinking Plastic Sarasota

Mr. Balck provided a presentation on Rethinking Plastic Sarasota and accomplishments.

Mr. MacNamara provided a presentation on the problem with plastics, weight of plastics, recycling, throwing away plastics, drinking straws, plastic litter, decomposing, and water systems.

Mr. Balck spoke on plastic leach into water and food, single use plastics, and BADFive logo.

Mr. MacNamara spoke on take away containers, plastic trilogy to include straws, lids and cups, alternatives to plastics, plastic bags, and alternatives

to bags.

Mr. Balck spoke on reusables.

Mr. MacNamara spoke on alternative utensils.

Mr. Balck spoke on alternatives to plastic to include plant based, glass, aluminum foil, stainless steel, difference one bag makes, greenwashing, Polylactic Acid (PLA), biodegradables, toolbox to include restaurant alternatives, dirty secrets of PLA, best practices, Skip the Straw campaign, relevant articles, meetings with Farmers Market, the carrot approach to include education through email, media, Chamber of Commerce website, paper signage, and awards for participating businesses.

Mr. MacNamara spoke on drain signs and plogging against pollution.

Mr. Balck spoke on parking lot pollution, county laws, St. Petersburg and Miami Beach bans on plastic straws, Preemption Law 2008, and Coral Gables ban.

Mr. MacNamara spoke on merchants of Venice, Be the Solution of Plastic Pollution calendar, eight ways to reduce plastic waste, rethinking plastic flyer, and answered board questions on thinking design, cost, effort, laws, education, recycling, Coral Gables challenges, economic data, green restaurant associations, and establishing an awards system.

Discussion took place on state laws, resolutions, restrictions, alternatives, payments for plastic bags, and requirements.

Mr. MacNamara answered board questions on how to spread the message.

18-3678 Venice Main Street: "Save the Straw" and Biodegradable Take Out Containers

Erin Silk, Venice MainStreet, spoke on Save the Straw initiative and read support letter from the president of Venice MainStreet.

Rod Nafziger, Venice MainStreet, spoke on cost, alternative methods, customer preference, take home containers, city needs, utensils, and education.

Discussion took place on merchant participation, convenient take out, tourism, economic vitality, education, tasting utensils, alternatives, and biodegradables.

Mr. Nafziger answered board questions on signage and marketing.

Discussion continued on table placard, biodegradable cost, and financial burdens.

Mr. MacNamara spoke on takeout containers, alternative cost, quality of food, container size, bag size, and answered board questions on finances, education in schools, and autism spectrum.

Mr. Courtney left the dais at 1:54 p.m. and returned at 1:56 p.m.

Ms. Stelzer spoke on city and private emails.

Mr. Jackson spoke on public record articles to include text messages, city and private cell phones, handling of record requests, and city and private email accounts.

Ms. Stelzer spoke on unopened emails.

Mr. Jackson continued on public record articles to include criminal charges and violations.
