SUBJECT: Approval of Rankings for RFQ 3092-18 Professional Engineering Services for Large Utilities Capital Projects – East Gate Utilities Relocation Phase 2 and Phase 3

Background:

Request for Qualifications (RFQ) 3092-18 Professional Engineering Services for Large Utilities Capital Projects was distributed on October 20, 2018; Twelve (12) proposals were received on November 21, 2018.

On January 10, 2019, an evaluation committee met to review, discuss, and score the seven (7) proposals received for East Gate Utilities Relocation Phase 2 and Phase 3. The seven (7) proposals were ranked in the following order and the top three (3) firms were invited in for interviews/presentations on January 25, 2018.
