#### FDOT FIVE YEAR WORK PROGRAM

Presenter: Ryan Brown, MPO

Summary: The Florida Department of Transportation (FDOT) has released the Tentative Work Program reports for FY 2019/20-2023/24 for Sarasota and Manatee Counties. This draft document provides a "snapshot" of roadway improvements, transportation alternatives, bridge, safety, and public transportation projects which will be funded during the five-year period which begins on July 1, 2019 and ends on June 30, 2024.

The process to develop this Tentative Work Program began in June 2018 when the Sarasota/Manatee MPO Board adopted the 2018 Project Priority list. This list was transmitted to FDOT, and the department worked closely with staff from the MPO and member jurisdictions to develop the Tentative Work Program. This document is considered a draft until it is adopted by the Florida Legislature and the budget is signed by the Governor.

The FY 2019/20-2023/24 Tentative Work Program was distributed back in December for review and can be found at the following link. The corresponding Summary of Changes for both Manatee and Sarasota County as well as highlights which summarize significant additions to the new draft tentative work program are attached.

# FY 2019/20-2023/24 Tentative Work Program Highlights

# **Desoto Bridge/Bridge Capacity**

FPN: 4448431 Project: Bradenton-Palmetto Connector Funding: \$3,360,004 FY19/20

FPN: 4426301 Project: Desoto Bridge from 21st Ave W to US 19 Bridge Funding: \$1,570,000 FY22/23

FDOT has programmed the PD&E (project development and environment) in the first year of the work program to determine the preferred capacity alternative between Bradenton and Palmetto. The Desoto Bridge replacement PD&E remains funded for FY22/23.

## **River Road**

**FPN:** 4450591 **Project:** River Rd from US 41 to I-75 **Funding:** \$73,863,116 FY20/21 FDOT has programmed CST for the widening of River Rd in the second year of the work program. This is in addition to the previously funded PE phase which is scheduled for the same year.

# Legacy Trail

FPN: 4404481 Project: Legacy Trail Extension Phase 1 Funding: \$8,557,000 FY19/20 and 22/23 FDOT has programmed \$1,057,000 for PE (design) in the first year of the work program and is to incorporate the pedestrian overpass at SR72. The 7,500,000 remains in FY 22/23 for construction.

## US 41/Gulfstream

FPN: 4381371-2 Project: US 41 at Gulfstream Roundabout and Landscaping Funding: \$10,801,759 FY19/20 and 22/23

The roundabout at US41 and Gulfstream now appears in the first year of the work program and is programmed through CST. \$1,252,114 has been programmed for landscaping on the project in FY 22/23.

## **Central Manatee Network Alternatives Analysis**

FPN: 4448071 Project: Traffic Operations Improvements in Downtown Bradenton Funding: \$1,001,000 FY 19/20 FDOT has programmed operational improvements in Downtown Bradenton in the first year of the work program as a result of recommendations made from the Central Manatee Network Alternatives Analysis (CMNAA).

FPN: 4448571 Project: Palmetto Trail Network Plan Funding: \$1,1000,000 FY19/20

FDOT has programmed the PD&E in the first year of the work program to evaluate and develop a trails network through Palmetto. A BUILD grant was also submitted for consideration in order to supplement this initial funding.

## I-75/Fruitville

FPN: 4206132 Project: I-75 at Fruitville Rd Funding: \$116,182,071 FY23/24

FDOT has programmed the PE and CST of the interchange at I-75 and Fruitville. This represents continued support from FDOT to further improve the local interstate network.
