## SECOND AMENDED REQUESTED OPERATIONAL and VOLUNTARY COOPERATION AGREEMENT

## WITNESSETH:

WHEREAS, pursuant to Chapter 23, Part I, Florida Statutes, known as the Florida Mutual Aid Act, the Sarasota County Sheriff's Office, the Longboat Police Department, the North Port Police Department, the Sarasota Police Department, the Venice Police Department, the Sarasota-Manatee Airport Authority, and the New College of Florida (formerly the University of South Florida) entered into a First Amended Requested Operational and Voluntary Cooperation Agreement in 1998; and

WHEREAS, the Sarasota County Sheriff's Office, the Longboat Police Department, the North Port Police Department, the Sarasota Police Department, the Venice Police Department, the Sarasota-Manatee Airport Authority, and New College of Florida have renewed and extended the First Amended Requested Operational and Voluntary Cooperation Agreement on seven occasions so that the First Amended Requested Operational and Voluntary Cooperation Agreement now extends through December 31, 2020; and

WHEREAS, the School Board of Sarasota County, Florida, has created the Sarasota County Schools Police Department and which has the authority under Part I of Chapter 23, Florida Statutes, Florida Mutual Aid Act, the provisions of Chapter 163, Florida Statutes, and other provisions of the laws of the State of Florida, to enter into the First Amended Requested Operational and Voluntary Cooperation Agreement and wishes to enter into such Agreement.

NOW, THEREFORE, in consideration of the foregoing and the covenants hereinafter contained, it is agreed between the parties as follows:

Section 1. The First Amended Requested Operational and Voluntary Cooperation Agreement entered into by the Sarasota County Sheriff's Office, the Longboat Police Department, the North Port Police Department, the Sarasota Police Department, the Venice Police Department, the Sarasota-Manatee Airport Authority, and New College of Florida (formerly the University of South Florida), and which has been most recently renewed through December 31, 2020 in the Seventh Renewal of the Combined Voluntary Cooperation and Operational Assistance Mutual Aid Agreement entered into by the Sarasota County Sheriff's Office, the Longboat Police Department, the North Port Police Department, the Sarasota Police

Department, the Venice Police Department, the Sarasota-Manatee Airport Authority, and New College of Florida are hereby incorporated by reference as if more fully set forth herein. Said First Amended Requested Operational and Voluntary Cooperation Agreement and Seventh Renewal of the Combined Voluntary Cooperation and Operational Assistance Mutual Aid Agreement are attached hereto as Exhibits A and B, respectively.

Section 2. The Sarasota County Sheriff's Office, the Longboat Police Department, the North Port Police Department, the Sarasota Police Department, the Venice Police Department, the Sarasota-Manatee Airport Authority, and New College of Florida hereby agree to the addition of the Sarasota County Schools Police Department into the First Amended Requested Operational and Voluntary Cooperation Agreement, as renewed by the Seventh Renewal of the Combined Voluntary Cooperation and Operational Assistance Mutual Aid Agreement.

Section 3. The Sarasota County Schools Police Department does hereby agree to enter into the First Amended Requested Operational and Voluntary Cooperation Agreement, as renewed by the Seventh Renewal of the Combined Voluntary Cooperation and Operational Assistance Mutual Aid Agreement and to be subject to the terms, conditions and immunities as more particularly set forth therein.

Section 4. This Second Amended Requested Operational and Voluntary Cooperation Agreement, as renewed, shall expire on December 31, 2020.
