#### V. Unfinished Business

<u>18-3305</u> Gary Youngberg: Update on Lord-Higel House

Gary Youngberg, Lord-Higel House, presented and spoke on the Lord-Higel House steps to opening checklist.

In response to board questions, Mr. Klinkhamer spoke regarding the recommended location for stormwater retention.

Mr. Youngberg commented on repairs, paint, and construction.

Discussion followed regarding project start date, timeline, phases and completion date.

Mr. Cautero spoke to project budget, volunteers, timeline, history, and contributions.

Mr. Youngberg commented on parking lot pavement.

Discussion continued regarding parking lot pavement, applying for an exception, and visitor feedback.

Ms. Trammell noted she is the president of Venice Heritage Inc., and spoke on council's support in rescuing the house structure, non-profit groups interested in restoring the house, grass roots program, fundraising, train car restoration, project donors, master site revisions, and project timeline.

Mr. Klinkhamer noted he will provide copies of the checklist to all board members and attach it to the Lord-Higel House file.

Mr. Cautero commented on project delay due to recession and funding.

Mr. Youngberg noted the annual meeting is April 24, 2019 at 2 p.m. at the Triangle Inn.

Discussion followed regarding insects on the south and west side of the structure.
