# **ORDINANCES - FIRST READING**

ORD. NO. 2019-31

An Ordinance of the City of Venice, Sarasota County, Florida, Adopting the Final Levying of Ad Valorem Taxes for the City of Venice for Fiscal Year 2020; and Providing an Effective Date

Ms. Stelzer stated the current millage, which is 3.700 mills, is the millage that was set last year, on which the last ad valorem taxes were calculated. The rolled-back millage is the rate required to collect the same amount of money as last year with this year's valuation, which is 3.5815 mills. The tentative operating millage is 3.700 mills, which was set by council in July, sent out in the TRIM notices from the Property Appraiser's office and represents an amount 3.31% greater that the rolled back rate. The voted debt service millage is .6200 mills.

Mr. Lavallee spoke regarding the proposed budget, capital projects,

transition of Sarasota County's Emergency Medical Services (EMS) and tree regulations to the city, future transportation proposal, and irrigation specialist position for irrigation and maintenance of the downtown beautification project.

Ms. Senne commented on the millage rate and debt service.

Discussion followed regarding projected revenue from property taxes, Bay Indies, millage rate, city services, tracking the city's productivity, allocating sale proceeds from the Hamilton Building for the police and fire department public safety facilities, resident comments on structural deficit, funding for EMS start up costs, lease purchases for rescue vehicles and equipment, projected revenue from EMS, general fund reserves, and the city's credit rating.

Mayor Holic opened the public hearing.

Ms. Stelzer noted written communication received after the agenda was posted will be included into the record.

No one signed up to speak.

Mayor Holic closed the public hearing.

Ms. Stelzer read the ordinance by title only.

A motion was made by Council Member Daniels, seconded by Council Member Fiedler, to approve Ordinance No. 2019-31 on first reading and schedule it for final reading.

Mr. Daniels issued a response to statements made by the Venice Tax Watch (VTW) group.

Council Members praised staff for their work on the budget and discussion followed regarding resident comments on tax increases and millage rate.
