STRATEGIC PLAN GOAL: Upgrade and Maintain City Infrastructure and Facilities

SUBJECT: Authorize the Mayor to Execute Amendment No. 1 to Work Assignment No. 401-18-08 with American Infrastructure Development, Inc. in the amount of \$177,915.00 to provide professional services to "Extend Taxiway D – Construction" at Venice Municipal Airport.

Background: On August 28, 2018, City Council authorized the Mayor to execute Work Assignment No. 401-18-08 with American Infrastructure Development, Inc. (AID) in the amount of \$168,606.00 to provide professional services for the Design of Taxiway D Extension at Venice Municipal Airport. The project allows aircraft to exit the primary Runway 13-31 faster, reducing runway occupancy time and increasing safety for larger aircraft arriving on Runway 31. This Work Assignment was completed, taking us through the permitting and bidding phases of the project. Three (3) bids were received on June 4th, 2019 and Ajax Paving was the lowest responsive bidder with a bid of \$1,994,467.38. City Council approved the award of the contract to Ajax Paving at the September 10, 2019 meeting.

Staff has negotiated Amendment No. 1 to Work Assignment No. 401-18-08 with AID for \$177,915.00 to provide construction phase services, including on site inspection, for the project.

On June 25, 2019, City Council approved acceptance of a grant agreement with FAA at 90% participation in the amount of \$1,964,029. On September 10, 2019 City Council approved acceptance of a grant agreement with FDOT at 5% participation in the amount of \$110,000. The Airport Fund will be responsible for the remaining 5% in the amount of \$110,000.

Requested Action: Authorize the Mayor to execute Amendment No. 1 to Work Assignment No. 401-18-08 between the City of Venice and AID for \$177,915.00.

If approved, staff requests the (3) attached originals be forwarded to the City Clerk's office to obtain the

Mayor's signature. One (1) signed original remains with the Clerk's office and two (2) originals returned to the Airport.
