Good evening City of Venice Planning Commission Members-

I believe referencing that is relevant with the possibility of a 45 foot structure towering over residential homes, an employee parking lot being located across the street from a major entry road for residents to get into the neighborhood (I would think the additional traffic and foot-traffic could be harmful and dangerous).

Lastly, I find the Public Meeting time to be quite unfortunate. It is a shame that residents of my demographic age, whom are still in the midst of their careers, really have little options to attend these meetings, and must offer our opinions in such a fashion I currently am.
