#### V. NEW BUSINESS

#### A. ORDINANCES

ORD. NO.An Ordinance of the City of Venice, Florida, Amending the Code of2019-29Ordinances, Subpart B, Land Development Regulations, Chapter 118,<br/>Vegetation, By Replacing in its Entirety with Chapter 118, Tree<br/>Preservation, Protection, and Replacement; Providing for Repeal of All<br/>Ordinances in Conflict Herewith; Providing for Severability and Providing<br/>an Effective Date

Mayor Feinsod read the ordinance by title only.

Recess was taken at 9:34 a.m. until 9:44 a.m.

Mr. Shrum spoke to the city establishing its own tree regulations, project timeline, extension of the interlocal agreement with Sarasota County to January 1, 2020, differences between county and city standards to include Florida Friendly Landscaping, the county's grand tree program, state law, single-family zoned lots, incentives to retain trees, mitigation fund, and attainable housing projects.

Discussion took place regarding trimming specialty trees, state law, protecting Heritage and Venetian trees, and incentives.

Mr. Shrum provided a presentation on Chapter 118 Tree Preservation, Protection and Replacement and spoke to primary function of ordinance, key changes since the July 9, 2019 presentation to council, and associated fee resolution.

Discussion followed regarding integrating the ordinance with the land development regulations (LDRs), tree inventory, goal for the city to achieve a tree canopy, clarifying language in the proposed ordinance on trimming and removal of trees, Florida statutes, exemption on single family zoned lots, the city's action plan to regulate the ordinance, and allocation of staff to implement, enforce regulations and issue permits.

Jeffery Boone, city resident, spoke to concern with the tree permitting process, language in the the ordinance on pruning Heritage and Venetian trees and tree protection and replacement plan, and requested the ordinance not be approved on first reading until clarification is received.

Discussion ensued on the exemption for residential properties less than one half acre, requirement to hire a certified arborist to trim trees with limbs larger than ten inches, and tree protection and replacement plan.

Mr. Yelverton explained the intent of requiring a certified arborist to prune trees.

Discussion continued on approving the ordinance on first reading with staff

revising the language for second reading and state statute.

Mr. Shrum noted the county does not exempt single family zoned properties.

Discussion continued regarding preserving the city's overall canopy, county fines, and mitigation options.

Mr. Boone noted concern with language in Section 118-8(f) stating "Mitigation shall not preclude nor be deemed a substitute for prosecution of violations of the provisions of this Chapter."

A motion was made by Council Member Fiedler, seconded by Council Member Moore, to approve Ordinance No. 2019-29 on first reading and schedule it for final reading with staff revising Chapter 118, Sections 118-7 and 118-8, for clarity and consistency. The motion carried by the following vote:

Discussion took place regarding mitigating nuisance concerns in the surrounding neighborhood, reducing speeding issues on Tarpon Center Drive, police enforcement, and park midnight closure.

Mr. Lavallee provided reasons for established park hours.

Discussion ensued on regulating activities, effective date of the ordinance, mitigating nuisance concerns, and flexibility to change park hours.

<u>19-4273</u> Authorize City Staff to Initiate Discussions with Sarasota County Regarding Future Expansion of E. Laurel and Pinebrook Roads

Ms. Weeden spoke to the basis of her request.

Discussion followed regarding the deadline to apply for road impact and/or mobility fees, improving the Pinebrook Road segment from Center Road to Laurel Road, council supporting the initiative to move projects forward, and opportunity for public/private partnerships.

A motion was made by Council Member Moore, seconded by Council Member Cautero, to approve Item No. 19-4273.

Pat Neal, Neal Communities, spoke on available funding sources, Laurel Road construction, public/private partnerships, Laurel Road right-of-ways, open fill and lakes, and requested to work with staff on a public/private partnership.

Ms. Weeden noted the public/private partnership has to be with the county as the property owner.

Discussion followed on response timeframe and scheduling a workshop on transportation priorities.

The motion carried unanimously by voice vote.

Discussion ensued on scheduling a workshop.

Ms. Weeden noted she would like to work with planning department staff on the transportation element of the comprehensive plan.

Recess was taken at 11:26 a.m. until 11:37 a.m.

Discussion followed regarding security cameras on city facilities, operating policy, surveillance at the beaches and beach parking lots, intent of security cameras, and zoom capacity and resolution.
