Per council's request, Ms. Fernandez explained the city's obligation to establish city zoning on this property.

Discussion followed regarding the property having a city zoning designation.

Council waived applicant's presentation.

Anita Cervi, 712 Golf Drive, being duly sworn, noted opposition to proposed Sheraton Hotel and commented on the proposed hotel at the airport.

Robert Conover, 605 South Green Circle, being duly sworn, noted opposition to proposed Sheraton Hotel and commented on micro wilderness and number of requested variances.

Mr. Shrum, being duly sworn, explained purpose is to rezone the property.

Mr. Lavallee suggested a public think tank.

Discussion ensued on having a public think tank, enforcing ordinances, downtown outdoor dining and ADA access, resident feedback, businesses using public property, and having a fee structure for use of public property for private benefits.

Ronnie Fernandez, Chair, Venice Heritage, Inc., spoke to project funds, timeline, contract with a new architect, construction of ADA ramp and restroom, and technical review committee (TRC) 's review of the site plan.

<u>19-4343</u> Pat Neal, Neal Communities: Update on Widening of Laurel Road and Request that City Council Authorize the City Manager Send a Letter to Sarasota County Requesting the Designation of \$400,000 in Impact Fees for a Conceptual Design Plan and to Utilize the Public Procurement Process for Laurel Road (15 min.)

> Pat Neal, Neal Communities, provided a presentation and spoke regarding US Highway 301 in Manatee County, Fort Hamer Bridge Project, Honore Avenue extension, Toledo Blade Boulevard, Bay Street sidewalk in Sarasota County, Fort Hamer extension in Manatee County, Laurel Road widening between Knights Trail Road and Jacaranda Boulevard, Laurel Road design section, right-of-way needs, potential funding sources, next steps to move forward with the project, and responded to council questions regarding the county's level of commitment on the project, funding, potential to exceed requested amount, and request to use impact fees.

Jerry Jasper, 130 Burano Court, on behalf of the Venetian Golf and River Club Community Association Board, spoke to supporting the public/private partnership as proposed by Mr. Neal to widen East Laurel Road.

A motion was made by Vice Mayor Newsom, seconded by Dr. Fiedler, to approve Item No. 19-4343.

Discussion followed regarding projection of Laurel Road, Jacaranda Boulevard extension, and public/private partnerships.

The motion carried unanimously by voice vote.

<u>19-4344</u> Camille Cline, Deputy Director of Development, Venice Theatre: The Next Act Capital Campaign and Request Council Consider Contributing to the Campaign (10 min.)

> Camille Cline, Deputy Director of Development, Venice Theater, provided a presentation and spoke on The Next Act capital campaign, Venice Theater to include economic impact and space needs, project timeline, donor contribution match, the theater's capital improvement history, funding needed for the arts education building, arts education building floor plan, main and technical arts building, endowment, recognition and giving societies, credentials, ways to give, and asked council to consider

contributing \$150,000 to the theater.

Mario Messina, 4029 Casey Key Road, Nokomis, expressed his support of the theater and noted it is an asset to the community.

Discussion ensued regarding the city making a donation and staff providing council with recommendations on potential funding sources and timeline.

A motion was made by Council Member Cautero, seconded by Dr. Fiedler, to direct staff to provide council with recommendations on potential funding sources, a timeline, and criteria for staff to establish a tangible public benefit. The motion carried unanimously by voice vote.

Dr. St. Luce provided a presentation and spoke on the information technology (IT) department, tech items supported, assisting other agencies, policies, focusing on security, ransomware, recent attacks, mitigating threats, and responded to council questions regarding malware attempts, training for city staff and advisory board members, full system restore, cyber insurance, and preventative measures for hardware updates.
