A RESOLUTION OF THE CITY OF VENICE, FLORIDA, AUTHORIZING APPROPRIATE GOVERNMENT OFFICIALS TO EXECUTE THE AMENDMENT TO THE PUBLIC TRANSPORTATION GRANT AGREEMENT FOR PROJECT NUMBER 436507-1-94-01 BY AND BETWEEN THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION AND THE CITY OF VENICE, FLORIDA, TO ADD STATE AND LOCAL FUNDS IN FISCAL YEAR 2020 AND TO EXTEND THE CONTRACT TERMS THROUGH DECEMBER 31, 2021, TO PROVIDE FOR THE CONSTRUCTION PHASE FOR THE AVIATION PROJECT FOR DRAINAGE IMPROVEMENTS, PHASE I; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Venice, Florida (City) acting for and on behalf of the Venice Municipal Airport has applied for Florida Department of Transportation (FDOT) funding to make certain improvements at the Airport; and

WHEREAS, the City has received a Public Transportation Grant Agreement (PTGA) from FDOT for Project Number 436507-1-94-01 and further, FDOT has programmed State funds for the project and has requested the execution of a PTGA to provide for participation in said project; and

WHEREAS, the City of Venice entered into a PTGA with FDOT on January 8, 2019, to undertake the project as authorized by Florida Statutes Section 332.006, and Florida Administrative Code Section 14-60; and

WHEREAS, an amendment to the existing PTGA is required to fund the construction phase of the project and extend the contract terms through December 31, 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA, as follows:

SECTION 1. The Whereas clauses above are ratified and confirmed as true and correct.

SECTION 2. That the Amendment to the Public Transportation Grant Agreement incorporating and governing the following project is approved:

436507-1-94-01 Drainage Improvements, Phase I

SECTION 3. That the Mayor and City Clerk of the City of Venice, Florida are hereby authorized and directed to execute the Amendment to the Public Transportation Grant Agreement for Project Number 436507-1-94-01 by and between the State of Florida Department of Transportation and the City of Venice, Florida which is intended to provide participation in the project at the Venice Municipal Airport.

SECTION 4. That upon approval and adoption, the City Clerk of said city is hereby directed to provide two certified copies of this resolution to the Florida Department of Transportation, District One, Intermodal Systems Development Office, 801 North Broadway Ave, Bartow, Florida 33830-1249.

<u>SECTION 5.</u> This resolution shall take effect immediately upon its approval and adoption as required by law.
