Mr. Shrum spoke to allowing opportunity for lower residential density by amending Strategy LU 1.2.3., meeting development standards on properties less than one acre, predictability in the comprehensive plan, and adding "or other unique conditions" to criteria number two.

Discussion followed regarding planning commission's approval, recommended language to criteria number two, special exception criteria for single-family residential properties, compatibility, and predictability.

Jeffery Boone, Boone Law Firm, spoke in support of the ordinance, and requested clarification on submitting a separate special exception request and purpose for adding language to criteria number two.

Mr. Shrum provided clarification for the record.

Mayor Feinsod closed the public hearing.

A motion was made by Vice Mayor Newsom, seconded by Dr. Fiedler, to approve Ordinance No. 2020-15 on first reading to include "or other unique conditions" added to criteria number two, and transmit to the Department of Economic Opportunity for review. The motion carried by the following vote:

Mr. Raymaker spoke regarding construction phases.
