Instructions for City of Venice Virtual Solid Waste and Recycling Stakeholders Work Group Meeting July 1, 2020

The July 1, 2020 Solid Waste and Recycling Stakeholders Work Group meeting will be conducted virtually.

Please note that Governor DeSantis' Executive Order Number 20-69 suspended the requirements of Section 112.286, Florida Statutes, the Florida Sunshine Law, that a quorum be present in person and that a local government body meet at a specific public place. The Executive Order also allows local government bodies to utilize communications media technology, such as telephonic and video conferencing for local government body meetings.
