The March 2, 2021 Planning Commission meeting will be held in council chambers at city hall. The meeting will also be simultaneously broadcast live on the City's website and through Zoom. Some members of the Planning Commission may participate in the meeting via Zoom and not be physically present

To participate in the Planning Commission meeting on March 2, 2021, which begins at 1:30 p.m., you have the following options:

1. Listen to the meeting via phone:

You may listen to the audio only from your phone by dialing 1-929-205-6099 and when the meeting ID is requested, enter 857 5905 5436 and then press the # key.

2. Watch the meeting online, but not participate:

3. Watch the meeting online and provide public comment prior to the meeting:

Provide your full name and home address and if you are a city business owner, list the business name and address. All comments received by March 2, 2021 at 12:00 p.m. will be distributed to the Planning Commission members and the appropriate staff prior to the start of the meeting.

4. Watch the meeting online and provide public comment during the meeting:

To request to speak virtually, you must complete the Request to Speak form prior to the start of audience participation or the agenda topic to be placed on a list.

You must fill out all required information or the form cannot be submitted. You will then be called upon to speak at the appropriate time.

5. Attend the meeting in-person at 401 W. Venice Avenue, Venice, FL 34285.
